

**RESOLUTION OF THE GOVERNING BOARD OF SPEED SPECIAL EDUCATION
JOINT AGREEMENT NO. 802 FOR DISMISSAL AND NON-RENEWAL OF
FIRST AND SECOND YEAR PROBATIONARY TEACHERS**

WHEREAS, the teachers hereinafter set forth were employed for the 2016-2017 school term as full-time first or second year probationary teachers; and

WHEREAS, the Governing Board has received and considered the recommendations of the Operating Committee; and

WHEREAS, the Governing Board has determined that said teachers shall be dismissed as of the end of the 2016-2017 school term and not re-employed for the 2017-2018 school term, pursuant to Section 24-11 of the *School Code of Illinois* (105 ILCS 5/24-11).

NOW, THEREFORE, BE IT RESOLVED by the Governing Board of SPEED Special Education Joint Agreement No. 802, as follows:

Section 1: The above recitals are incorporated into and made a part of this Resolution.

Section 2: That the following first and second year probationary teachers are hereby dismissed and not renewed effective as of the end of the 2016-2017 school term and shall not be re-employed as teachers in SPEED Special Education Joint Agreement No. 802 for the 2017-2018 school term:

Section 3: The President and Secretary of the Governing Board are hereby authorized and directed to give such teachers written Notice of Dismissal and Non-Renewal, substantially in the form attached to this Resolution as Exhibit 1 and incorporated by this reference, by regular

mail and by certified mail, return receipt requested, at least forty five (45) days before the end of the 2016-2017 school term.

Section 4: That the Superintendent or designee shall also personally deliver a copy of said notice to said teachers.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage.
