### **Superintendent Report**

**Update**: Superintendent Rappold reported on April highlights; they are diligently working on the Certified staff negotiations and working with Sandra Rivas on the closeout for this fiscal year, and next fiscal year's budget.

**2025-2030 Strategic Planning:** Superintendent Rappold stated that the meeting took place last week at BHA. Discussions went well. They discussed the funding and budget for the coming years. Mr. Running Fisher noted that it was a very informative training. Everything should be ready to go by June.

**4-Day Instructional Week Survey Review**: Superintendent Rappold stated the results of the survey were shown to be a majority in favor of the 4-day week. Superintendent Rappold explained the grouping and graphing for the for the results of the 4-Day survey, noting that she will provide a better breakdown of the numbers at the next scheduled board meeting. Mr. Bremner asked for a breakdown of numbers from the towns that information was taken from regarding test scores, attendance, etc.; Donna asked for clarification as to which day the schools take for their extra day, is it Fridays or Mondays, or even the middle of the week and requested information regarding school

size and whether or not the information provided from other schools is reflective of the population that Browning Public Schools has, noting the differences between Class A school vs. Class B or Class C schools.

**Summer School**: Jennifer Wagner stated that the registration process will be different this year. Registration will be online and open prior to the end of the school year. It will run on a 4-day week beginning June 9 through June 26 with a start time of 8:30 AM-2:00 PM. Napi School will host Little Learners through 8<sup>th</sup> grade. High School summer school will be held at BHA. All groups will have a trip which will be attendance driven. No transportation will be provided.

**PS Building Principal Demographics 2024-2025**: Superintendent Rappold explained the building demographics to the board. Discussion took place regarding Principal and teacher compensation and the comparison of the step scale vs. years of experience. Mr. Bremner asked for clarification regarding the compensation for new Principals. After reviewing the wage scales provided, he asked whether a pay cut would take place if an experienced teacher with the relevant degree were to accept a principal position. Ms. Rappold stated, yes, in some situations that may be the case. Further discussion took place regarding wage scales and where BPS sits statewide on said wage scales. Information will be provided at a future meeting.

**Policy/Procedure 2100-P (1) – School Calendar and Day – Schedules and Programs**: Superintendent Rappold explained the changes needing to be made. Language should reflect 1080 hours, rather than 180 days. Also noting that it would not be a "formal change" rather just an amendment in order to be in compliance. Brian Gallup reiterated that the board would only ask for an amendment and it can be brought back to the next meeting for further discussion.
