D. Staff Reductions, Moreen Martell

In the approval of the personnel consent agenda, the board has now approved the 1.5 administrative staff, 11.5 teaching positions and 2.0 gifted and talented positions as part of the budget reductions. This has been a thoughtful and difficult process involving the termination of good staff members.

Discussion - How many people is this – Doesn't have that for you right now but will be able to in June. Retirements have helped reduce the number of terminations. Saddened to let phenomenal staff go and also how this affects students and their learning.

 E. Resolution Proposing to Place Erica Carlson on Unrequested Leave of Absence
 Erica is an Art Teacher at Buffalo High School. There are no probationary staff in the art department. Erica will have rights to an Art position in our District for five years.

BE IT RESOLVED by the School Board of Independent School District No. 877, as follows:

- 1. That it is proposed that Erica Carlson, a teacher of said school district, be placed on unrequested leave of absence without pay or fringe benefits, effective at the end of the 2008-09 school year on June 30, 2009, pursuant to M.S. 122A.40, subdivision 10 and ARTICLE VI, Section 3., Subdivisions 1-6 of the current Master Agreement between the School district and the exclusive representative.
- 2. That said proposed placement on unrequested leave of absence is not the result of the implementation of an education district agreement.
- 3. That written notice be sent to said teacher regarding the proposed placement on unrequested leave of absence without pay or fringe benefits as provided by law and said notice shall include a date for hearing if requested and be in substantially the following form:

NOTICE OF PROPOSED PLACEMENT ON UNREQUESTED LEAVE OF ABSENCE AND NOTICE OF HEARING DATE, IF REQUESTED

Dear Ms. Carlson:

You are hereby notified that at the regular meeting of the School Board of Independent School District No. 877 held on March 19, 2009, consideration was given to your placement on unrequested leave of absence without pay or fringe benefits as a teacher of Independent School District No. 877, and a resolution was adopted by a majority vote of the Board, proposing your placement on unrequested leave of absence effective at the end of the 2008-09 school year on June 30, 2009, pursuant to Minnesota Statutes 122A.40, subdivision 10 upon the grounds described in said statute and which are specifically as follows: financial limitations.

Your proposed placement on unrequested leave of absence is not the result of the implementation of an education district agreement.

Under the provisions of the law, you are entitled to a hearing before the school board provided that you make a request in writing within fourteen days after receipt of this notice. If no hearing is requested within such period, it shall be deemed acquiescence by you to the school board's proposed action.

6. **REPORTS**

A. Activities Reductions, Mark Mischke

Tom Bauman has contacted the activities which were proposed to be cut regarding their interest in self-sufficiency and cooperative opportunities. Some concern from these groups if they are able to be self-sufficient for one year why wouldn't the district want them to continue with that. Alpine Ski, Speech and Dance Team were not interested. Drum line would want to figure the difference is cost depending if they need to rent a practice facility. Boys Swim and Diving is interested in fund themselves for one year and already have the money collected.

Regarding Cooperative opportunities – St. Cloud has mentioned an interest with ski. St. Cloud also practices at Powder Ridge in Kimball.

Question regarding program cost for Alpine ski – this is one of the more expensive activities.

Question regarding difference between club and co-op. Cost is main difference and not being recognized as a High School League activity. There is competition amongst clubs. Our coaches may not be employed by the hosting district. Could a team contract a bus to take them to the host school for practices - yes. Are we assured that these other district's programs are not in danger of being cut. Yes, this has been asked. Is there a concern for Watertown regarding Title IX implications if our swim/dive team co-ops with them. That is probably why they are asking for numbers of participants.

Title IX – Compliance looks at opportunities and averages compared to student enrollment over the past two years. We are 5% below in girls and 5% above in boys. Five percent is the allowable margin. By looking at these numbers, if we keep boys swimming, we would need to cut boys in some other areas or add girls in. Could for example, we limit the number of freshmen boys in an activity - possibly. If we would reduce the number of boys, this would also decrease the amount of fees collected. Consideration is also given to balance of opportunities in each season. Reduction in number of coaches was made in 2004.

Supt. Comments – Everyone agrees that extra-curricular activities are beneficial to student success. When these activities were added, the question was asked – can we afford this. Knew we could sustain them at the time, but could not predict future years. According to the parent surveys, we will be at the maximum our families can afford for activity fees with the proposed increases. Seven years ago, cuts were made equitably and across the board. Will continue to look for efficiency and reductions across all activities. Will look at requests for advertising. Will continue with donations practice so that the programs are not driven by what donations would be given for. Title IX – concern is when "willful" decisions are made. Superintendent's recommendation –

- Middle school is ready to go ahead with a fee of \$80 and will add a fine arts fee, reduce number of contests and travel.
- High school raise fees to \$85/\$120/\$155. Look at one-year donation possibility but be concerned with if this puts us further out of compliance.
- Don't give up on the cooperative possibilities.
- If donation/self-sufficiency is granted it should be for one year and then revisited.

Discussion - Would like this on the next workshop. Would like to look at options to reduce number of boys and increase number of girls.

- B. Policies, Anita Underberg These are suggested revisions from MSBA and incorporate practices currently in place:
 - 1. #203.5 School Board Meeting Agenda language regarding the development of the agenda
 - 2. #204 School Board Meeting Minutes language regarding recording of closed meetings and maintenance of those recordings
 - 3. #210 Conflict of Interest language regarding contract approval when spouse of a board member is a member of the class of employees contracting with the school board.
