Unlocking Rigor and Complexity in Math

DESCRIPTION:

The training sessions will focus on the more advanced Readiness Standards found on the new STAAR state assessment. The intent of the trainings will be to provide knowledge and strategies on how to approach instruction and how teach to the new rigor and complexity found in math problems. Teachers will learn ways to help students understand problems involving 2 and 3 step operations, process skills, and how to analyze problems in order to extract the important facts. The participants will learn to apply data through the use of tables/charts and other graphic sources to solve problems involving variables.

Primary attention will be given to the shifting of teaching styles and methods in order to meet the new demands for more in-depth reasoning and critical thinking involved in daily instruction. The trainings will focus on category 1. Numbers/Operations and Quantitative Reasoning and category 2.Patterns/Relationships and Algebraic Reasoning. Teachers will have an opportunity to work in groups on math lessons and solve problems through a hands-on approach.

TARGETED AUDIENCE:

The staff development academy will provide training and support to $3^{rd} - 6^{th}$ grade teachers that work with migrant students at designated south side and north side schools. Priority is being given to those schools not meeting AYP standards this year, and for those campuses indicating low performance on nine week common assessment results throughout the year.

RATIONALE:

The sessions are meant for teachers that work throughout the year with migratory students who experience interruptions in schooling and who are considered academically disadvantaged due to their migratory lifestyle. The primary focus is on the closing of our district achievement gaps among our special populations.
