If we do not have the listed information by the July 1st date, your program will be placed on probation which will mean:

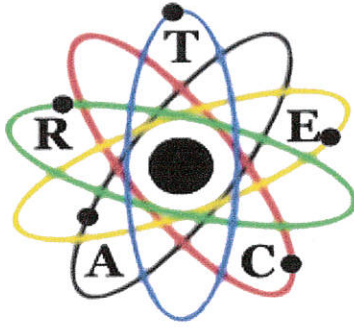
- 1—Very limited eligibility for any ARTEC/ARTE I grants.
