Jennifer Engelbrecht a teacher at Ann Windle addressed the Board regarding the Pre-K issues at her campus and the current overcrowding.

The following parents all addressed the Board regarding Autism education and programing for DISD autistic students: Jana Edwards, Tess Sullivan & Brandon Woltman.

Discussion & Review of 1<sup>st</sup> Quarter Growth Report Rocky Gardner, representative from Templeton Demographics, and Rod Reeves, Facilities Coordinator, presented the first quarter growth report for 2012. Mr. Gardner highlighted that the Dallas-Fort Worth area is second nationally in housing starts in the first quarter of 2012, with Denton County ranking fourth overall. Denton ISD posted the fourth largest number of homes closing in the area during that same time period and posted a 26 percent growth in number of housing starts compared to the first quarter of 2012.

Discussion of Budget 2012-2013 Debbie Monschke, Executive Director of Administrative Services, continued updating the Board with a preliminary budget for the 2012-13 school year. The board is considering a proposed budget that includes a salary increase of about 3 percent with a \$700 minimum per employee. The district has not provided salary increases to exempt and support staff in two years and one year for teachers.

Continued Discussion of Elementary Programs Mary Helen Martin, Director of Elementary Curriculum provided the Trustees with the most up-to-date projections for 2012 – 2013 elementary staffing so that the best decisions can be made on behalf of students, families, campuses, and the district.

At Ann Windle every classroom is currently used for students including: 12 Head Start Classrooms, 3 Prekindergarten Classrooms, 3 PPCD Classrooms, and 1 Deaf Education Classroom (19 classroom units occupying 18 classroom spaces). Classrooms are 730 square feet versus the current

elementary prototype for prekindergarten of 900 square feet.

Newton Rayzor Elementary is projected to have increases in enrollment, 36 of 36 classrooms will be utilized for Prekindergarten through 5<sup>th</sup> grades. That leaves Foreign Language, EXPO, Social Adjustment Class, Math Interventionist, Play Therapy, and Community in Schools without space in the building and three portables in need of renovation as the only remaining option.

Paloma Creek Elementary has 12 appropriate rooms for prekindergarten through 1<sup>st</sup> grade. These rooms are 900 square feet and have restrooms within each of the classrooms. Projections for 2012 - 2013 include 2 prekindergarten classes, 6 kindergarten classes, and 6 first grade classes. There are 14 classes that need to use the 12 spaces available for prek-1<sup>st</sup> grade. All classrooms are currently in use for Prekindergarten - 5<sup>th</sup> grades and other special programs at the campus with projections for 2 additional general education positions for 2012 - 2013.

Mrs. Martin presented several options to alleviate the overcrowding at these three campuses.
