 members, agents, employees and volunteers as additional insured's as respects to the Organizations use of District facilities. Said
 insurance must be primary to and non-contributory with any insurance carried by the District and include waiver of subrogation in
 favor of the District, its board members, agents, employees and volunteers.
- 2. Licensee agrees to provide all required certificates of insurance to the Parkrose School District at least fifteen (15) calendar days prior to the time of occupancy.
- 3. The parties agree that the specified coverage of limits if insurance in no way limit the liability of the licensee.
- Licensee shall provide a Certificate of Insurance containing a notice of cancellation clause not less than 30 days prior to cancellation or non-renewal of any such policy.

Laws - Rules - Regulations

- 1. - Full payment and proof of insurance must be received prior to use of any facility.
- Application must be completed and turned in 30 days prior to rental date for consideration of reduced fees. Religious based organizations are excluded from receiving reduced fees due to Federal Law.
