The Board of Trustees of the Tupelo Public School District convened in a special called meeting of the Board held in open session at 9:30 a.m. on Tuesday December 13, 2016, at the Hancock Leadership Center, 1920 Briar Ridge, Tupelo, Mississippi.

I. CALL TO ORDER

Board President Joe Babb called the meeting to order.
