2014-5-2-2 President's Mid-Year Status Report on Strategic Plan for 2013-2014

BE IT RESOLVED, that the President presents the Mid-Year Status Report of Strategic Goals for 2013-2014 to the Board of Trustees of Collin County Community College District. No action is required.

President Israel reported on the mid-year status of the Strategic Goals for 2013-2014. No action was required or taken.

Strategic Goal 1: Improve academic success by implementing strategies for completion.

- The number of students achieving significant levels of completion as identified by the THECB will be increased.
 - Create an early alert system that allows faculty to identify at-risk students before they reach academic probation.
 - Increase academic advisor training and enhance training materials.
 - SCC will pilot "triage" student service area; advisors received a manual outlining functions and services. New online wait system (QLess) to be launched this summer; advisors will be trained in the functions of that product.
- Financial Aid/Veteran's Affairs accuracy and responsiveness will be improved.
 - Meeting with Financial Aid leadership conducted at least twice a month. The entire department is participating in NASFAA University (intensive 13-modual course providing a comprehensive review of federal aid).

- Reports developed to resolve errors on student accounts before information is released to the students .
- Streamlined award process for 2014-2015 aid year.

Strategic Goal 2: Provide access to innovative higher education programs that prepare students for constantly changing academic, societal and career/workplace opportunities.

- New programs will be developed in key workforce and academic areas.
 - New program: Certified Veterinary Assistant; 37 enrolled in level 1 in spring 2014.
 - In fall 2013, 156 students took the Phlebotomy Technician exam with a 91% pass rate.
 - In fall 2013, 133 students took the Clinical Medical Assistant exam with a 91% pass rate.
 - Feasibility studies for AAS and possible certificates in Diagnostic Sonography and Occupational Therapy Assistant have been completed. Preliminary results indicate a need for these programs in Collin County.
 - Proposal for a new AS degree in Engineering/Pre-Engineering being developed. Proposed program will have a track for Electrical, Mechanical, and Civil Engineering to align with UT Dallas (EE), and with the Statewide Engineering transfer Compacts.
 - Plans to offer Certified Fiber Optics Technician training in fall 2014.
 - Division of Fine Arts continues to expand course availability as space/resources allow:
 - At Central Park Campus:
 - 9 sections of Art courses
 - 1 section of Communication Design courses
 - · 3 sections of Dance courses
 - 5 sections of Music courses
 - 2 sections of Photography courses
 - 3 sections of Theater courses
 - At Preston Ridge Campus:
 - 27 sections of Art courses
 - 7 section of Communication Design courses
 - 23 sections of Dance courses
 - 21 sections of Music courses
 - 5 sections of Photography courses
 - 5 sections of Theater courses
- Collin College will be positioned as a leader in refining employment skills for advanced workplace opportunities and workforce training in a global market.
 - Fall 2013 schedule featured four student-written and video success stories in Certified Medical Assistant, Certified Bookkeeper, Certified Project Manager, and Internet Marketing Professional.
- Partnerships with local ISDs will be expanded leading high school students to certificates and associate degrees at Collin.
 - Business pathway developed with Wylie ISD.
 - Technical Dual Credit classes at Prosper (DFTG 1309 and ITSY 1400) and Wylie East HS (ITNW 1358 and RBTC 1305) were successful.

- Business Management pathway developed with Farmersville ISD allowing students to graduate from high school and simultaneously complete a certificate in Business Management beginning with the rising junior class in fall 2014.
- STEM division will once again offer technical dual-credit STEM courses scheduled for both Wylie HS and Wylie East HS in fall 2014. Technical dual-credit courses planned at McKinney ISD for the 14-15 academic year.
- Career clusters will be developed to expand students' choices leading to seamless transition.
 - Seamless pathways between Collin programs and the new Career Endorsement Plan being developed with ISDs:
 - Computer Information Systems (STEM Endorsement)
 - Communication Design and Commercial Music being planned for Allen ISD.
- The Central Park Campus Master Plan will be enhanced to include elements of a comprehensive campus and a Health Sciences facility that will establish Collin College as a Health Science Hub for the region.
 - Board of Trustees unanimously approved PBK Architects to provide architectural services for the proposed Health Sciences Building, Conference Center, and related parking at CPC.

Strategic Goal 3: Engage faculty, students and staff in improving a district-wide culture of adherence to the Collin College Core Values.

We have a passion for: Learning; Service and Involvement; Creativity and Innovation; Academic Excellence; Dignity and Respect; Integrity.

- Customer Service and Culture of Student-Centered Decision Making
 - Courses offered to improve employee skills in telephone etiquette, active listening, and managing situations with difficult people. Through April, 157 employees completed these courses.
- SACSCOC reaffirmation of accreditation will be achieved.
 - Advisory visit by SACSCOC V.P.; changes were made to processes and narratives based on his recommendations.
 - Compliance Certification document completed and mailed to off-site review committee and SACSCOC.
 - QEP Development Team submitted 5-point proposal to Leadership Team.
- Core values will be modeled through communication and will be improved across the district.
 - Series of slides using CougarVision and quotes and photos emphasizing Core Values were created in fall 2013 and continue to be shown.

Strategic Goal 4: Enhance the College's presence in the community by increasing awareness, cultivating relationships, building partnerships and developing resources to respond to current and future needs.

- The college's overall approval ratings in the community surveys will be improved including perceptions of academic quality and contributions to the local economy.
 - Professor of the Year accolade leveraged via billboard, newspaper articles, community newsletter, You Tube videos, website, social media and ads.

- Academic Excellence commercial ad in movie theater, full-page Dallas Morning News ad and ½ page ads in Star Community Papers.
- Pandora mobile ad campaign launched April 2, 2014.
- New home page design and CMS to be launched in May 2014.
- Social Media Procedures Guide approved for rollout.
- Gifts and grants to the college and foundation will be increased by 3%.
 - Spring Fundraiser raised over \$200,000 for scholarships for students. In addition, the event has garnered several awards from CASE and NCMPR.
 - Secured two \$100,000 commitments for endowment as well as a \$2 million gift. Major gift initiatives are progressing.
 - Initial proposal for developing alumni program approved by the Foundation and Leadership Team.
 - Foundation has secured a sponsor for the first proposed activity for the 2014-2015 year, CAFÉ talks.

2014-5-2-4 Approval of the Adoption of the Bluebonnet as the Official Flower of Collin College

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves the adoption of the Bluebonnet as the official flower of Collin College.

On motion of Dr. Collins, seconded by Ms. McCall, the Board of Trustees of Collin County Community College District formally adopted the Bluebonnet as the official flower of Collin College.

Chairman Hendricks said this begins a new tradition to create a lasting tribute to our alumni, former students, and colleagues. Bluebonnets will be planted strategically on campuses starting this summer so they will bloom for the first time in spring 2015 during the college's 30th anniversary. The flower's royal blue petals topped by a crown of white parallel the college's official colors of blue and white and the flowers will bloom each year just prior to commencement as a prelude to a new class of graduates. Trustee Collins and his wife have generously agreed to donate seeds from a field of bluebonnets on their property to seed the first symbolic planting at the Central Park Campus, since it was the first campus. Areas at Central Park, Courtyard, Spring Creek and Preston Ridge campuses have been designated for seeding.

President Israel added that this will be good for the institution to embrace and will coincide with the launch of the 30th anniversary celebration, graduation, and the starting of the first ever alumni association.

He said he looks forward to another fine project and national training site from PBK Architects and Pogue Construction. Dr. Israel said the project is on a tight timeframe to have parking ready before classes begin in the fall.

In answer to Mr. Wainwright's question, Vice President/CFO Ralph Hall said that if the costs go over the total amount, it is not the responsibility of the District. President Israel said if the costs are lower, it is a savings to the District.

INFORMATION REPORTS

Ralph Hall, District Vice President of Administrative Services/CFO presented the following information reports:

Budget Status Report as of 04/30/14

For the month ending April 30, 2014, expenditures exceeded revenue by \$5,794,263. However, year-to-date revenue exceeded expenditures by \$38,678,504. Mr. Hall noted that revenues for taxes are at 100% for the year.

Investment Schedule as of 04/30/14

Investments for the month of April had a book value of \$265,118,994 and a market value of \$265,122,631 with TexPool paying .03% and and TexStar paying 0.04%. Two Fannie Mae's were paying .12%. The U.S. Treasury benchmark was .04% on April 1, 2014, and .03% on April 30, 2014. A short-term certificate of deposit with Bank of America is paying .13%.

President Israel announced the following:

1. A special thank you goes to VPP/Athletic Director Sherry Schumann for her leadership and hard work on the national tennis championship held at the Spring Creek Campus. We appreciate our student-athletes, Head Coach Marty Berryman and Assistant Coach Rod Coltman. Unfortunately, Collin did not win; however, we received many compliments on our terrific facilities and how we hosted the event.

2. For 2014, Collin had 20 first time candidates taking the National Certification Exam to earn the title of Certified Surgical Technologist (CST). For the first time, all 20 candidates passed the exam – a 100% pass rate that exceeded last year's rate of 95%. We appreciate Senior Vice President Colleen Smith, Vice President/Provost Sherry Schumann, Dean Abe Johnson, Program Director/Clinical Coordinator Jeanne Glapion, and the faculty and staff working with our surgical technology program.

3. Congratulations to Professor of History Kyle Wilkison who was selected as a 2014 Piper Professor by the Minnie Stevens Piper Foundation. Piper Professors are recognized for superior teaching at a Texas college or university. Dr. Wilkison is one of 10 professors statewide to be honored, and one of only two community college professors named among institutions such as the University of Texas Southwestern Medical Center, Texas A&M University, Texas Christian University, Texas Tech University, the University of Houston, and Lamar University. This proud accomplishment was celebrated with Dr. Wilkison at a reception in his honor on April 30 at the Spring Creek Campus. 4. Congratulations to Kirk Bell of the Collin Foundation Board of Directors. He serves as President of the District 5810 Rotary Club. Under his leadership, District 5810 Club was recently named the Rotary Club of the Year from among the 67 clubs throughout the district and Kirk was named the Best President. 5. Faculty and students from Collin's Institute for Hospitality and Culinary Education participated and represented the college at the City of Plano Learn 2 Live Green event.
