# **TAG Presentation – Val Reynolds**

Coordinator of OSD Talented and Gifted Coordinator Val Reynolds explains her role working in the Ontario School District, Ms. Reynolds states she has worked in education for 36 years. Ms. Reynolds explains that her day to day is working with teachers and students are gifted and talented. There is a lot of work that goes into coaching teachers to notices signs that a student may be involved in the TAG program; referrals come from the teachers that may notice signs. Ms. Reynolds states that when she gets referrals she meets with those students and does a holistic assessment on the student, this was a suggestion by the state. Ms. Reynolds shows that highlights strengths and talents from students; there are a lot of curriculum that goes into teaching students and expanding their strengths. Teachers are a very important part to this process; teachers go to many trainings to better support students. # <sup>9</sup> Superintendent Report – Nikki Albisu

Superintendent Albisu states there are many state and federal updates going on, I am working on a letter to Congressmen Bentz. There are COSA meetings, and Superintendent Albisu states she is also sending letters to COSA. There are also going to be increased rates in health insurances, so we are tracking how we are doing with our spending throughout the time we have to pay for that increase. ESSER dollars also going away and we are monitoring our funding goes towards PERS. There will be a lot of streamlining many things so we can be well prepared in our general reserve. The proposed budget for the 2025-2026 school year we will be in a deficit, but we will be okay with using some of reserve for year one. Our audit has been a frustrating one, Superintendent Albisu states that the dates have been moved back a ton. We sent a lot of communication to the auditors on our deadline; we are getting new auditors soon.

#### **Public Comment**

There was one public comment by Kristin Wheeler who shared how the union negotiations went. There was a lot of discussion about contract law, and we talked about what teacher priorities. The district and the school side was very collaborative. Staff were well represented during these conversations; much of the conversation was to make sure compensations represents the rigger they do. We wanted to collaborate with the district and we want to be competitive, so Ms. Wheeler continues states that the union wanted to take the innovative and make sure the approach is taken into consideration. Teachers modify instruction, they are creating safe and creative platforms, and I know the district and school board value that work. The union would like teacher compensation to match the hard work and we want to promote teacher moral. Ms. Wheeler concludes by thanking the district for great negotiations.
