Re: Rowan Williams School Choice Appeal

To whom it may concern:

I am writing this appeal on behalf of my daughter, Rowan Williams. I am appealing the Lincoln School District's denial for school choice. Rowan attended kindergarten for the 2020-21 school year at Jerry Pop Williams Elementary in Farmington, AR. There we have established connections with faculty, her peers, and special education support team for the services she receives for speech therapy. While Farmington School District accepted Rowan's school choice application, Lincoln School District denied the application due to meeting the 3% transfer out of district cap.

Changing schools and districts after her first year would be detrimental to Rowan for the following reasons: consistency of academic performance as evidenced by the state provided school report cards, lack of continuity in established peer and mentor relationships vital to social and emotional growth, and lack of continuity of support established for her speech and language disability. For these reasons I am asking the State Board of Education to overturn the denial of school choice and to allow Rowan to attend Farmington School District in the fall and for the rest of her academic career.

I am writing this appeal on behalf of my student Rowan Williams, in response to Lincoln Consolidated School Districts denial for school choice. Rowan attended Kindergarten at Jerry "Pop" Williams Elementary School for the 2020-2021 school year and it would be imperative that she continue her education at Farmington Public Schools.

During her time at Williams Elementary we established Rowan's support team. This team is made up of her Classroom Teacher (myself), Speech & Language Pathologist, Instructional Facilitator, and Teaching Assistants, all with whom she has well-established relationships with. Rowan is quiet, shy and timid. Her family has worked to be her biggest advocates, by communicating frequently with her teacher, allowing her to attend the summer reading program at Williams Elementary and building relationships with other students outside of school through playdates. These relationships took time to build and it would be detrimental to the progress she has made academically and socially to deny her an education with Farmington Public Schools at Williams Elementary.

The academic progress she has made this past school year was not easy for her, but as a team we have all been determined to help her be successful in making that progress. For the 2021-2022 School Year we have taken data from the end of the 2020-2021 school year and will take data from the summer reading program to quickly identify where to begin in continuing her academic progress.

I strongly believe that we will continue to see Rowan progress academically and socially if she continues her education at Farmington Public Schools, this is because of the team that was established for Rowan at Williams Elementary and the relationships she has made.
