- **Weekly Door Sweeps** continue at every campus - good work, maintenance dept. responding well; a few times doors have been found in “non-compliance, still rare
- Since start of school August 23, 2022 our campuses have conducted the following **safety drills**:

- **Security camera projects** (new and replacement) are moving forward - DAEP/Tiger/BP/HS; 10+ cameras replaced; DAEP/Tiger project in progress, challenging

- **“Safety”(100) magnets** - received and delivered; extras to secondary/elem campuses in Feb
- **Safety and Security Committee Meeting #3 March 6th** - Initial report from TXSSC on EOP and “annexes”; Safety Upgrades and projects, door sweeps; future meeting date - 7/31/23
- **SPAT grant** - “Silent panic” buttons are soon to be required in Texas schools; we applied for a grant(12/2), got it; purchased RAPTOR Emergency Management System; initial implementation meeting March 6
- **TEA/Texas Safety grant** - Rcd NOGA March 1, \$200K; planned fencing, doors, and necessary equipment
- **TASB Risk Security Cyber Security grant** - Rcd \$2500(Feb.) for SISD staff cybersecurity training; KnowB4 contacted.
- **Region 13 Safety Audit (3-Year)** - underway, in-district for 3 days, working handbooks, met with maintenance and campus principals, conducted “intruder” audit; preliminary report with commendations and recommendations received March 19th.
