Badger-Two Medicine Society Overview

All students at BHS have an Advisory class. Advisory serves as a homeroom or homebase for students. Students have the same Advisory teacher each year that will follow them through their experience at BHS. Each Advisory has been asked by BHS Administrators to form a society, based on traditional Blackfeet Societies. Each society is to develop a single, unique service purpose (or long-term service project) for our school community and the Blackfeet Nation as a whole. Ms. Andreas' Advisory has decided to form the Miisinsskiisis 'tăaNăatoōkyoōkăasii Society, which translates to the Badger-Two Medicine Society.

Goal of the Miisinsskiisis 'taa Naatookyookaasii Society:

Members of the Society will work to learn more about the cultural and environmental significance of the Badger-Two Medicine area while simultaneously working to preserve the area for future generations through the passage of the **Badger-Two Medicine Protection Act**.

What is the Badger-Two Medicine Protection Act?

The Badger-Two Medicine Protection Act is the result of several years of extensive conversations and collective effort by the Blackfeet Tribe, Glacier-Two Medicine Alliance, other conservationists, hunters and anglers, landowners, outfitters, recreationists, and other tribal and non-tribal residents throughout the region. This undertaking grew out of years of building relationships and shared understanding as the aforementioned groups have worked together to rid the Badger-Two Medicine of illegally issued oil

and gas leases. Most importantly, unlike past protective proposals floated for the region, this Act represents the Blackfeet Nation's vision for how they want their sacred lands managed. The Act has been endorsed by both the Tribal Business Council and traditional leaders as well as the Blackfoot Confederacy.

learn cultural and traditional practices. Their efforts to learn more about and protect the Badger-Two Medicine will do this while also exposing them to local, state, and national leaders and organizations working to create positive change and bring awareness to the sovereignty of all Native people. Additionally, When young people contribute their ideas and energy to addressing social issues, they begin to see themselves as capable leaders who can make important contributions to the lives of others. Youth who might otherwise feel academically or socially inferior to their peers realize that their unique strengths are needed to build a better world. The empowering effects of changemaking spill over into adulthood, as youth retain their motivation to help others and pursue their goals with confidence.
