# REGULAR SCHOOL BOARD MEETING November 4, 2010

A regular meeting of the School Board of Independent School District No. 831, Forest Lake, Minnesota, was called to order by President Bill Bresin on Thursday, November 4, 2010 at 7:00 p.m. at the District Office Building. Following the Pledge of Allegiance, roll was called and the following members were present: Bill Bresin, Kathy Bystrom, Joe Grafft, Dan Kieger, Karen Morehead, Rob Rapheal, Erin Turner, and Superintendent Dr. Linda Madsen, ex officio.

The meeting agenda was reviewed and Joe Grafft will be giving the Finance Committee report.

### 4. VISITORS:

Listening Session – Members Dan Kieger and Erin Turner conducted the 6 pm Listening Session and reported that discussion centered on the levy votes and moving forward.

Joe Johnson addressed the School Board on energy renewal projects and cost savings, and "greening" the Forest Lake School District.

Kristine Granias and Maurya Laqua spoke about the secondary credit change options.

Former School Board Member Julie Corcoran and co-chair of the vote yes committee, thanked administration and the School Board for all their effort in getting the levy and bond information out.

#### 5. STUDENT ACHIEVEMENT:

Lino Lakes Elementary – Principal Ron Burris introduced Lino Lakes Elementary 5<sup>th</sup> grade teacher Amy Greenfield and two fifth grade students, who reported on their study of wolves.

Music Curriculum Review – Maurya Laqua, Lisa Sauer, Sandy Kaslow Briggs, and Kristine Granias presented a report on the district's K-12 Music program.

## Positive Happenings:

Joe Grafft, along with several other School Board Members and administration, attended the Youth Service Bureau's Black Tie banquet at Running Aces last month.

Dan Kieger announced that FFA won four more national awards.

Karen Morehead attended the Wyoming forum, an EMID meeting, the Central Montessori PTA meeting, and went to a meeting at the new Oneka Elementary School. She announced that CME will be holding a turkey bingo on November 12, and donations are coming in for TEFFLA (the district's foundation).

Bill Bresin attended the Linwood Elementary book fair and Forest View's open house.

Erin Turner attended Central Montessori's conferences, and announced that the Rotary Club has purchased dictionaries for district third and fourth grade students.

Kathy Bystrom attended the Forest Lake/Forest View Elementary PTA meeting, the "Shout Out" event, a Schools for Equity in Education (SEE) meeting, the SHIP School Health Council meeting, and announced that there will be another school turkey bingo – this one at Southwest Junior High on November 19.

Buildings & Grounds – Member Rapheal reported that the Buildings & Groups committee reviewed the 2010 project and discussed the levy and bond referendums.

Communications – Member Bystrom reported that the Communications Committee discussed the levy and bond referendums, the  $100^{th}$  graduating class celebrations, and the new ECFE program in Lino Lakes.

Finance – Joe Grafft reported that the Finance Committee reviewed the budget, budget projections for 2011-12 and the proposed levies.

Policy – Dan Kieger reported that the Policy Committee reviewed the policies on maltreatment, child neglect, and the community use of school facilities.

Staff Welfare – Bill Bresin reported that the Staff Welfare committee discussed the Hall of Fame, an all-school reunion, student credit options, the Director Administration and Human Resources position, and the levy and bond referendums.

City of Forest Lake – Member Morehead reported the Chris Johnson is the mayor-elect, and urged more partnerships between the school district and our cities and communities.

Superintendent's report – Dr. Linda Madsen reported that the Board will need to meet to discuss the levy and bond referendum votes and start talking about potential budget reduction areas. The district had set aside the federal EduJobs monies to offset expected budget reductions next year, STEP students are doing some Project SEARCH internships. The Open Minds Club raised \$1,400 by sponsoring a 5K event, interviews for the new Director of Administration and Human Resources will be tomorrow (November 5), and the fall play is "You're a Good Man Charlie Brown". Both boys' and girls' cross country teams are going to state competition in Northfield, and Eric Kaluza has been named "coach of the year". The senior high Veteran's Day program will be on November 10 with Director Ron Spies as the keynote speaker.
