Disposal of Foreclosed Property

Recommendation:

Recommend approval of the resolution conveying title of properties

to the County of Wharton

#### **Background and Rationale:**

The two (2) tracts of land mentioned in the resolution have been foreclosed due to non-payment of property taxes. These properties are currently a burden to Wharton County Junior College, along with all of the current taxing entities. The County of Wharton is working closely with the City of El Campo and the Tres Palacios Project to acquire these properties located in the area of the project. Tex. Tax Code §34.05 provides that in lieu of a public auction, property may be resold at any time through a private sale and for any amount with the consent of each Taxing Unit entitled to proceeds of the sale under the judgement. For this purpose, the City of El Campo, Texas desires to acquire the properties and plans to use the awarded fund to improve roadside ditches, replace culverts, and install an underground storm sewer to prevent deterioration of the south side of El Campo, Texas. Current value of these properties is \$118,905.00 and the back taxes due to WCJC are \$26,112.77.

# RESOLUTION AUTHORIZING PRIVATE SALE OF PROPERTY HELD IN TRUST BY THE COUNTY OF WHARTON, TEXAS

WHEREAS, pursuant to judgments of the District Court of Wharton County, Texas, for the foreclosure of the tax liens securing payment of delinquent property taxes, accrued penalties and interest owed to taxing entities and court costs owed to the District Clerk in the causes referenced below, tax liens on the properties described herein were foreclosed on and at a public auction the properties were offered for sale by the Sheriff of Wharton County, Texas; and

WHEREAS, as set by law, the properties did not receive a sufficient bid at the auction and, as a result, the properties were struck off to The County of Wharton, Texas, as Trustee, for the use and benefit of itself and The City of El Campo, Texas, El Campo Independent School District, Coastal Bend Ground Water Conservation District, Wharton County Emergency Services District No. 4, Wharton County Emergency Services District No. 1, Wharton County Fire District No. 1, Wharton County Junior College District and West Wharton County Hospital District (Taxing Units); and

WHEREAS, Sheriff's Deeds conveying the properties to the Taxing Units were recorded in the Official Public Records of Wharton County, Texas; and

WHEREAS, TEX. TAX CODE §34.05 provides that in lieu of a public auction property may be resold at any time through a private sale and for any amount with the consent of each Taxing Unit entitled to proceeds of the sale under the judgment; and

**WHEREAS**, the Texas General Land Office Regional Mitigation Program awarded funds to The City of El Campo, Texas, for various projects that will improve drainage and repair drainage infrastructure in El Campo, Texas, and surrounding areas; and

**WHEREAS**, the properties identified in this Resolution are located in the area of the projects. For this purpose, The City of El Campo, Texas, desires to acquire the properties and plans to use the awarded funds to improve roadside ditches, replace culverts, and install an underground storm sewer to prevent further deterioration of the south side of El Campo, Texas; and

**THEREFORE, BE IT HEREBY RESOLVED,** Wharton County Junior College District is in support of these projects and authorizes The County of Wharton, Texas, to convey the properties described herein to The City of El Campo, Texas, for its sole benefit and use for the projects as stated herein; and

THEREFORE, BE IT HEREBY FURTHER RESOLVED, pursuant to this Resolution, and as authorized by the Resolutions of the other Taxing Units, The County of Wharton, Texas, shall execute deeds conveying the right, title and interest of the properties described herein to The City of El Campo, Texas. This Resolution shall take effect immediately from and after its passage in accordance with the provisions of the law.
