REQUEST TO TAKE BIDS FOR A NEW/USED PATROL VEHICLE:

The Sheriff's Office is requesting to take bids for a new/used patrol vehicle. This would be to replace vehicle #55 which is currently driven by Sheriff Kieliszewski. Vehicle #55 would then be placed for sale. We currently have \$50,000 in this line item and \$31,990.62 is marked to pay for a current lease payment for four Ford SUV's. That leaves \$18,009.38 in that line item plus we are in the process of selling some older vehicles with the proceeds going to this line item. Line item # 205-302-977.002.

I am requesting to advertise for bid new in car tablets/ laptops to replace old computers that are having difficulty staying running. This becomes a hazard to the officer and the daily operations of the officer on their shift. We check preliminary pricing in the past at they are around \$4,200 each, we currently have 12 patrol officer's and one officer has the newer system. We are requesting \$45,000.00. We would be requesting the funds come from the Fund Equity.




