1. Provide a DETAILED RATIONALE explaining how the waiver will enhance student learning opportunities, promote innovation, or increase equitable access to effective teachers. Include information about the problem or obstacle, if any, the waiver will help the district overcome.

The Van Buren School District (VBSD) is requesting a one-year waiver from A.C.A. 6-10-106 which establishes the first allowable day of class as the Monday of the week that contains August 19. For the 2024-2025 school year, that date will be Monday, August 19.

As presently constructed, law allows for a considerable range of possible start dates. At the earliest, the first day of school can be August 14 which was the case for the 2023-2024 school year. At the latest, the first day of school would be August 20, which under the current law will occur in 2029.

Specifically, VBSD is requesting approval to allow the first day of school to be Wednesday, August 14, 2024. We believe this early start to the school year will enhance student learning opportunities in the following ways.

- Allow a balance in the number of days for each semester and, as a result, in each quarter. Without
  an early start waiver there are significantly fewer days in the first semester. This type of imbalance
  can only be corrected by extending the first semester until after the winter break which results in
  issues for semester exams, grading, etc.
- Increase the potential of the school year ending in May rather than extending into June when student attendance will be a challenge. Additional days missed due to inclement weather further exacerbates this issue.
- Allows more days for instruction prior to the spring testing window giving students a greater advantage for higher achievement.
- Students involved in activities and athletics will keep a similar practice calendar regardless of the school start date, therefore, they will already be on campus for practices and events.
- 2. Provide a detailed explanation of how the services being waived will be provided for students.

With approval, the Van Buren School District will create a school calendar with a start date of August 14, 2024. The proposed calendar will continue to provide the required 1068 hours of instruction for all students K-12 as well as all required services.

3. Provide a detailed explanation of how the district will monitor and evaluate the effectiveness of the waiver.

The Van Buren School District will monitor student assessment results and student attendance data related to the earlier start date to determine the effectiveness of the early start date.
