511 <u>STUDENT</u> FUNDRAISING

I. PURPOSE

The purpose of this policy is to address <u>student</u> fundraising efforts <u>by students and</u> <u>employees of the Duluth Public Schools</u>.

II. GENERAL STATEMENT OF POLICY

The school board recognizes a desire and a need <u>by some student organizations</u> for fundraising. The school board also recognizes a need for some constraint to prevent fundraising activities from becoming too numerous and overly demanding on employees, students, and the general public. <u>All fundraising activities must be</u> <u>approved by the School Board before they begin.</u>

III. DEFINITION

A. <u>Fundraising examples include, but are not limited to, grocery bagging</u> <u>for tips, gift and discount card sales, book fairs, food sales, plant sales,</u> <u>Box Tops for Education, and crowdfunding activities.</u> <u>Any activity for</u> <u>the purpose of raising funds for a club, team, or school is considered a</u> <u>fundraiser.</u>

III. RESPONSIBILITY

- A. The building administrators shall be responsible for developing recommendations to the superintendent that will result in a level of activity deemed acceptable by employees, parents, and students. Fundraising must be conducted in a manner that will not result in embarrassment on the part of individual students, employees, or the school.
- B. All fundraising activities must be approved, in advance, by the administration. Participation in nonapproved activities shall be considered a violation of school district policy.
- C. The superintendent shall be responsible for providing coordination of student fundraising throughout the school district as deemed appropriate.
- D. The school district expects all students who participate in approved fundraising activities to represent the school, the student organization, and the community in a responsible manner. All rules pertaining to student conduct and student discipline extend to student fundraising activities.
- E. The school district expects all employees who plan, supervise, coordinate, or participate in student fundraising activities to act in the best interests of the students and to represent the school, the student organization, and the community in a responsible manner.

F. The building administrators shall be responsible for complying with the District's Wellness Policy (Policy 533).

IV. <u>ANNUAL MONTHLY</u> REPORT

<u>The superintendent</u> <u>All fundraisers</u> shall <u>be</u> report<u>ed</u> to the school board, <u>at least</u> <u>annually</u>, <u>on a monthly basis and will describe on</u> the nature and scope of student fundraising activities approved pursuant to this policy.
