Canine Contraband Detection: Service Contract for San Diego ISD

This document shall serve as an agreement between Canine Contraband Detection (hereinafter "CCD") and San Diego ISD (hereinafter "District") for drug awareness and detection services to be provided during the school year(s) 2018-2019.

The District may choose to sign this agreement for a one or two consecutive school year period. If a two-year period is chosen the following clause will be applicable:

NON-APPROPRIATION OF FUNDS CLAUSE: Renewal of this contract (if appropriate) will be in accordance with Texas Local Government Code, Sec 271.903 concerning non-appropriation of funds for multi-year contracts. The district reserves the right to rescind the contract at the end of each fiscal year (as of August 31) if it is determined that there are insufficient funds to extend the contract.

It is understood that the district has a policy clearly defining contraband as all drugs of abuse (in the broadest terms), alcoholic beverages, firearms and ammunition, fireworks, explosives and/or explosive devices. The policy has been explained and made available to all faculties and student bodies within the District. Violations are considered inimical to the welfare of students and contrary to the District's desire to foster an atmosphere conducive to education.

CCD shall provide contraband inspection services utilizing contraband detection canines. Such inspections may be conducted on an unannounced basis under the auspices of the District administration. Communal areas, empty classrooms, lockers and parking lots (vehicles) shall be subject to inspection. Contraband seized on the District's property is the responsibility of the District. Suspected drugs of abuse may be field-tested to provide preliminary identification of the drug at no charge.

CCD agrees to provide 30 Half Day Visit(s) per year at a rate of \$195.00 per dog/handler team for the 2018-2019 school year(s). (This includes either AM hours from start of classes to normal lunch break or PM hours after lunch break to final bell. *Teams are directed by administration and will follow their direction as to times to arrive/depart within the above referenced time frames.)

There will be no charge for travel time or mileage fees. School assignments shall be coordinated between CCD and the program coordinator for the District. It will be the District's responsibility to provide CCD with dates that are inappropriate for a visit. A regular charge will apply for all visits on dates not listed as inappropriate. There will be a regular charge for scheduled visits not cancelled two (2) working days prior to a team's scheduled arrival.

CCD will provide three (3) demonstrations relative to presentations to school boards, PTO/community groups, and non-profit drug awareness groups at no charge to the District. Extra searches, in-school assemblies, and classroom presentations will be available upon request at the same price as set forth above. Extra searches (emergency searches, luggage/bus checks, prom, grad-night, etc.) conducted before or after normal school hours or on weekends will be available upon request at twice the current Half Day rate.

Demonstrations requested by the District for Red Ribbon Week must be scheduled in advance and will be performed at no charge to the District (during normal school hours). Scheduling will be limited to the first five requests of all school districts serviced by CCD.

All canines utilized by CCD are certified as reliable either "In-House" and/or by an independent testing organization. CCD will provide canines that are capable of detecting the following substances: ammunition, beer, cocaine, fireworks, guns (recently fired or loaded), heroin, liquor, marijuana, medications (prescribed and over-the-counter which are commonly subject to abuse), methamphetamines, and wine. Additional substances may be taught to specific dogs at any time. Canines that only detect illicit drugs are available upon request at no additional charge. Both contraband and drug only canines can be utilized on any visit upon request.

CCD is licensed by the Texas Department of Public Safety's Private Security Bureau (C-8030), the Drug Enforcement Administration (RC02213431) and the Texas Department of Public Safety.

CCD carries the legal requirements of general liability coverage.

***Please Note: Billing Procedures**

(1) An invoice will be sent to the District as services are rendered, reflecting detection activities performed within the District.

(2) A one-time invoice for the total contract amount reflecting a 2% discount (Discount is only applied if payment is received within 30 days of receipt).
