Presentations/ Recognitions

International Baccalaureate (IB) Update

The Board was provided an update of the current DP, MYP, and PYP activities at Denton High School, Calhoun Middle School, N. Rayzor Elementary School, and Borman Elementary School.

The IB programs have made inroads at each of these campuses in expanding the global perspective of academics and how students fit into that model. A recent evaluation from IB leaders was overwhelmingly positive with

recommendations given to continue the progress the IB curriculum is having in the district. Among the happenings at the district's IB campuses during the 2013-14 school year are:

- An increase in diploma candidate students, from 15 in 2013 to 27 in 2014 at Denton High
- A renewed focus on leadership skills with DP and MYP IB students from Denton High helping future IB DP students at Calhoun Middle and Houston Elementary in academic assistance and community service projects
- Implementing curriculum maps at Calhoun Middle to improve inquiry from students and communication among teachers
- The addition of French as a second language at Borman Elementary and the continued usage of technology and research skills in the PYP program at both Borman and Newton Rayzor

Utility Management Energy Audit The Board received the mid-year report for energy consumption and utility management from Dan Edwards, Manager of Energy Project Development with TD Industries, and Paul Andress, Executive Director of Operations. The report showed that while the unit cost for electricity increased by 4.8 percent, the district's consumption decreased by the same number. Additionally, the irrigation unit cost increased by 9.7 percent, yet district consumption decreased by 21 percent – even with the addition of Myers Middle to the district's total square footage. Overall, the district maintained a cost of \$1.46 per square foot, the same as its average during the 2009-10 school year, through its energy conservation and green measures. Mr. Edwards pointed out that the district's total utility costs increased by approximately \$612,000, which he attributed to higher natural gas prices and the longer than normal winter.

Examining Grading Practices

Vicki Christenson, Director of Secondary Curriculum, provided the Board an overview of the district's updated secondary grading practices that is designed to provide a better method of reporting student knowledge. Mrs. Christenson outlined the steps the Academic Leadership Team has taken during the past two years to implement grading practices that fall in line with the district's goals. The district gathered input from international educational experts, local administrators, as well as district teachers and parents. The end result was a grading system developed by the ALT that ensures parents and students can understand if students are learning and mastering the content, while not penalizing the students for behavioral issues. The new system provides students more feedback than just a number. This system will require a 9-week grading period to allow teachers more time for

feedback and accurate assessments and will:

- Hold students accountable for learning the curriculum tied to standards:
- Provide "value learning" over earning numerical points; therefore, it will not be acceptable to just "take a grade" when learning has not occurred;
- Recognize that feedback is a valuable tool to increase learning;
- Understand that errors are part of the learning process;
- And allow students to take personal ownership of their own learning.

Child Nutrition Meal Prices

Robin Wantland, Director of Child Nutrition provided the Board with information on upcoming lunch price increases. For school year 2014-2015, school food authorities that, on a weighted average, charged less than \$2.65 for paid lunches in school year 2013-2014 are required to adjust their weighted average lunch price or add non-Federal funds to the non-profit school food service account. Although a waiver may be requested, there is an application process with no guarantee of approval. The waiver, if granted, would apply only for one year. Denton ISD currently has an average weighted lunch price of \$2.62.
