The final recommendation of the committee was for the textbook <u>Montreasures</u> by the publisher <u>McHillan McGraw-Hill</u> . Stated below is the rational for my objections.
When looking at the three textbook adoptions
and comparing them. I found that the McMilland McGraw-Hill textbook does not have the same stills covering both the english and spanish versions.
