As a result of the 2025 Bond Election, the District issued a Request for Qualifications (RFQ) 26-006 entitled "Geotechnical Engineering Services for the DeSoto ISD 2025 Bond Program" with the following schedule of events:

On December 2, 2025, the District received fourteen (14) Statements of Qualifications (SOQs) from firms in response to the RFQ. All fourteen (14) SOQs submitted were deemed responsive and compliant with the RFQ requirements.

The evaluation resulted in the recommendation of the top four (4) firms for Geotechnical Engineering Services to support the 2025 Bond Program. In accordance with the Texas Government Code §2254.004, staff recommend that the Board approve the firms identified as qualified providers of Geotechnical Engineering Services based on demonstrated competence and qualifications; and give authorization to enter into contracts for these services in support of the 2025 Bond Program.
