## MEMORANDUM OF UNDERSTANDING Between Browning Public School District and Peter Graham Dunn

This Memorandum of Understanding (hereinafter referenced MOU) describes and confirms an agreement between Browning Public Schools and Peter Graham Dunn to provide a paid internship for an environmental instructor beginning SY 2017-18 through 2018-2019 SY, Kara L. Kokovich. The purpose of the agreement is to formalize a professional/technical contract for outside environmental instruction inquiry based services, and clarify expectations and relationships between both parties.

# PETER GRAHAM DUNN RESPONSIBILITIES (Grant Provider):

Provide funding to the Browning Public Schools for an environmental educator at the beginning of each month. The funding will provide for salary at \$35,520.00 and plus fringe benefits at 18%, excluding health insurance.

# **BROWNING PUBLIC SCHOOL RESPONSIBILITIES:**

The school will provide office space, health insurance, ancillary supplies and transportation to make a successful environmental education program. Professional support will be provided to the environmental educator through the Director of Goshen College Environmental Education, David Ostergren. However, Browning Public Schools will provide supervision and evaluate the environmental educator.

The MOU shall be effective January 1, 2018 to May 31, 2019. Either party has a right to terminate the MOU upon a 30-day notice to the other party.
