BACKGROUND AND SIGNIFICANT ISSUES: This proposal allows Child Nutrition Program - South Texas Cooperative (CNP-STC) members the ability to procure goods and/or services from a pre-qualified list of responsive and responsible Vendors, known as a company or firm whose purpose is to provide food items, beverages, paper products, plastic goods, and other goods and/or services not available through other procurement means, excluding fresh produce. It also allows CNP-STC members the ability to order food and/or supplies directly from manufacturers. Item descriptions, specifications and/or technical requirements and estimated quantities and pricing, and/or price lists and/or catalogs have been provided by each vendor enclosed. Region One ESC and its cooperative members are required to conduct a cost or price analysis for the procurement of goods and/or services not listed in the items tab, and within the scope of services offered with this bid solicitation. Cooperative members are responsible for the selection of goods and/or services available to meet their individual menu needs, nutrition goals, storage capabilities, and student preferences.

On May 23, 2017 Region One Education Service Center Purchasing Department, acting on behalf of its CNP-STC members, received sixty-five (65) responses to Manufacturer Direct Ship to District Warehouse Commercial Products RFP 19-AGENCY-000050. Proposals were evaluated to select the best qualified vendors based on the established criteria. The tabulation and evaluation summary is enclosed. Sixty-two (62) vendors are being recommended for award. Vendors recommended for awarded had complete request for proposal submissions with an evaluation score of 70 or greater. Three (3) vendors are not recommended for award because a "No Bid" response was submitted, the proposal submission was incomplete and/or had an evaluation score of less than 70. The term of this proposal is effective July 1, 2018 – June 30, 2019 with three (3) one-year extension options if all parties are in agreement.

**RELATED GOALS:** To assist Child Nutrition Program – South Texas Cooperative members in Region One and other school districts, charter schools, and governmental entities throughout the State operate more efficiently and economically (TEC §8.002).

COST AND FUNDING SOURCES: Cooperative members order products and services directly through the awarded vendor(s). A cost recovery fee is paid by members to join the CNP-STC. Of the net total invoice amounts on all services performed under this proposal, a flat fixed service fee rate of \$0.0100 cents on each \$1.00 dollar of total sales made through this contract paid to the Region One ESC by the vendors.

**EXECUTIVE DIRECTOR'S RECOMMENDATION:** Recommend approval of Child Nutrition Program-South Texas Cooperative Manufacturer Direct Ship to District Warehouse Commercial Products RFP 19-AGENCY-000050 to the vendors listed on the attachment.
