## RESOLUTION ESTABLISHING COMBINED POLLING PLACES FOR CERTAIN MULTIPLE PRECINCTS AND DESIGNATING VOTING HOURS FOR SCHOOL DISTRICT ELECTIONS NOT HELD ON THE DAY OF A STATEWIDE ELECTION

BE IT RESOLVED by the School Board (the "Board") of Independent School District No. 308 (Nevis Public School) as follows:

- 1. Pursuant to Minnesota Statutes, Section 205A.11, the precincts and polling places for School District elections are those precincts or parts of precincts located within the boundaries of the School District which have been established by the cities or towns located in whole or in part within the School District. The Board hereby confirms those precincts and polling places so established by those municipalities.
- 2. Pursuant to Minnesota Statutes, Section 205A.11, the Board may establish a combined polling place for several precincts for school elections not held on the day of a statewide election.
- 3. The combined polling place described in **Exhibit A** to this Resolution is hereby established to serve the precincts specified for all School District special and general elections not held on the same day as a statewide election. The designation herein made shall remain in effect unless the Board, in a subsequent resolution adopted by not later than December 31 of each year, changes the combined polling place, as provided in Minnesota Statutes, Section 205A.11, subd. 2(b).

- 4. The Clerk is hereby authorized and directed to designate a new or different polling place (i) in the event that the combined polling place named in this resolution has become unavailable for use as provided in Minnesota Statutes, Section 205A.11, subd. 2 (b)(2); or (ii) in the event of an emergency in accordance with Minnesota Statutes, Section 204B.175.
- 5. As required by Minnesota Statutes, Section 204B.16, subdivision 1a, the Clerk is hereby authorized and directed to give written notice of a new polling place location to each affected household with at least one registered voter in the School District whose school district polling place location has been changed. The notice must be a nonforwardable notice mailed at least twenty-five (25) days before the date of the first election to which it will apply. A notice that is returned as undeliverable must be forwarded immediately to the appropriate county auditor, who shall change the registrant's status to "challenged" in the statewide registration system.
- 6. Pursuant to Minnesota Statutes, Section 205A.09, the combined polling place named herein will remain open for voting for School District elections not held on the same day as a statewide election between the hours of 12:00 o'clock p.m. and 8:00 o'clock p.m.
- 7. The Clerk is directed to promptly file a certified copy of this resolution with the County Auditor of Hubbard County.
