

RESOLUTION transferring funds from the Operations and Maintenance Fund of School District Number 26, Cook County, Illinois, to the Capital Projects Fund of said School District.

WHEREAS, the Board of Education (the “*Board*”) of School District Number 26, Cook County, Illinois (the “*District*”), is authorized to transfer money from the Operations and Maintenance Fund of the District (the “*O&M Fund*”) to the Capital Projects Fund of the District (the “*Capital Projects Fund*”) in accordance with the rules and regulations of the Illinois State Board of Education and specifically Section 100.50(d)(2) of Title 23 of the Illinois Administrative Code (the “*Section 100.50(d)(2)*”); and

WHEREAS, the Board has determined and does hereby determine that it is necessary and in the best interests of the District that the School Treasurer who receives the taxes of the District transfer \$8,000,000 from the O&M Fund to the Capital Projects Fund:

NOW, THEREFORE, Be It and It Is Hereby Resolved by the Board of Education of School District Number 26, Cook County, Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Transfer to Capital Projects Fund. The School Treasurer who receives the taxes of the District is hereby directed to forthwith permanently transfer \$8,000,000 from the O&M Fund to the Capital Projects Fund as of the date hereof to be used as provided in Section 100.50(d)(2).

Section 3. Severability. If any section, paragraph, clause or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution.

Section 4. Repealer and Effective Date. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed and that this Resolution shall be in full force and effect forthwith upon its adoption.
