RESOLUTION AUTHORIZING ACQUISITION OF REAL PROPERTY COMMONLY KNOWN AS 1300 RONZHEIMER AVENUE, ST. CHARLES, KANE COUNTY, ILLINOIS

WHEREAS, the Mid-Valley Special Education Cooperative, Kane County, Illinois ("Mid-Valley"), is authorized by the *Illinois School Code* to acquire real property in order to further the goals of its educational mission; and

WHEREAS, the Board of Education of St. Charles Community Unit School
District No. 303 ("District 303") currently holds title to the parcel of real estate commonly known as 1300 Ronzheimer Avenue, St. Charles, Illinois, and legally described in Exhibit A, attached hereto and incorporated herein (the "Property"), and has indicated its desire to transfer the Property to Mid-Valley in the spirit of intergovernmental cooperation; and

WHEREAS, Mid-Valley currently leases the Property for use in its educational mission and Mid-Valley desires to purchase the Property from District 303 and District 303 desires to sell the Property to Mid-Valley pursuant to the terms and conditions of the Real Estate Sale Agreement, attached hereto and incorporated herein as Exhibit B.

NOW, THEREFORE, BE IT RESOLVED by the Executive Advisory Board of Mid-Valley Special Education Cooperative, Kane County, Illinois, as follows:

Section 1: That the above recitals are incorporated into and made a part of this Resolution as though fully set forth in this Section 1.

Section 2: The Executive Advisory Board hereby approves and authorizes the purchase of the Property and the execution of the Real Estate Sales Agreement in

substantially the form attached as Exhibit B, subject to review and approval of legal counsel.

Section 3: The Executive Advisory Board hereby authorizes and directs the Executive Director, Carla Cumblad, or her designee, to take all necessary steps to effectuate the acquisition of the Property in accordance with the terms of this Resolution, and to sign all necessary documents on behalf of Mid-Valley incident to the closing on said Property.

Section 4: This Resolution shall be in full force and effect immediately upon its passage and any prior resolutions or action by the Executive Advisory Board inconsistent or in conflict with the terms of this Resolution shall be repealed to the extent of said inconsistency or conflict.
