**6.0** **SUPERINTENDENT’S CELEBRATION(S)**

**6A** **RECOGNITION OF RECHS BAND**

Mr. Miguel Cabrera recognized the following students for their accomplishments at the ATSSB All-Area Band contest on January 8, 2022: Angel Garza, Victoria Avila, Sonya Tobias, Caleb Morales, and Tommy Elijah Cabello. He also recognized David Hernandez, Baritone – 2<sup>nd</sup> Chair – All-State. He is the first All-State Band Member from Robstown in twelve years since 2010 and the first-ever All-State Baritone Player from Robstown in school history. He thanked the Board, administration, and parents for their support.

**6B** **PROUD YOU’RE A PICKER AWARD**

Mrs. Diana Silvas reported that nominees for the Proud You’re a Picker Award can be nominated by their peers, by students, and by community members. **7A** **SCHOOL BOARD RECOGNITION MONTH – JANUARY 2022**

Dr. Jose Moreno announced that January was School Board Recognition Month. He read the following from the proclamation signed by Greg Abbott, Governor of Texas “School Boards are an integral fabric woven into the tapestry of the Texas education system. They work with parents, education professionals, and community members to create successful learning environments for our students. Our school boards continue to be instrumental as they tackle new challenges for Texas public schools and serve the ever-evolving needs of our students. Texans know that they can count on their school board members, along with other dedicated school administration officials, to create opportunities to discuss important issues, develop innovative solutions,

and empower educators while remaining focused on their students' future.” On behalf of the school district, student representatives from each of the campuses presented goody baskets to the Board. Also, a certificate was presented to the board members, a dinner was held in their honor before the Board meeting, and the choir and band performed during the dinner.

7C ESC II SCHOOL BOARD TRAINING ON THE UPDATE TO THE EDUCATION CODE FOR BOARD OF TRUSTEES ON THE 87<sup>TH</sup> TEXAS LEGISLATIVE SESSION, JANUARY 19, 2022, RISD ORTIZ INTERMEDIATE – 6:00 P.M.

Dr. Jose Moreno announced that the school district would be hosting the ESC II Update to the Education Code for Board of Trustees on the 87<sup>th</sup> Texas Legislative Session on Wednesday, January 19, 2022, at Ortiz Intermediate at 6:00 p.m.

7D PRESENTATION OF GOGUARDIAN

Dr. Jose Moreno reported that the school district's priority was safety, and they were very excited about the new initiative that Rachel Medrano would be presenting to the Board. Mrs. Medrano presented an overview of the GoGuardian to the Board. She reported that GoGuardian was a software that helps schools easily manage their devices, better understand their students, and keep them safe online. She reviewed the GoGuardian Administrative and GoGuardian Fleet. The GoGuardian Fleet easily tracks, assigns, and reports on the school district's Chromebooks. It has tracking for damage and repair, device location tracking, quick assign and unassign, has advanced data management, bulk editing capabilities, and robust inventory. The GoGuardian Beacon is a machine-learning solution that notifies pre-determined school staff of instances where students may be at risk-of suicide, self-harm, or harm to others. GoGuardian Teacher is a classroom management tool for Chromebooks and it will allow teachers to see what is on the screen of every student in the classroom. Mrs. Nataline Hall reported that the GoGuardian Beacon had been implemented during the winter break and they were able to respond and intervene to any crisis that a student might have been going through.

7E 2021-2022 RISD INSTRUCTIONAL MATERIALS ADVISORY COMMITTEE MEMBERS FOR PHYSICAL EDUCATION AND HEALTH ADOPTION

Mrs. Lorena Ceballos presented the school district's advisory committee members for Physical Education and Health Adoption and the Proclamation 2022 for Physical Education and Health Adoption Timeline to the Board.

#### ACADEMIC QUARTERLY PROGRESS REPORT

Dr. Jose Moreno announced that this report would be presented by Mrs. Lorena Ceballos on how the school district has been progressing academically. She reported that she would be presenting the information on the performance and growth for the Fall Benchmark Data. The performance is how a student did on this year's test or measure, and the growth is how a student did on this year's STAAR test compared to last year's STAAR test at a lower grade level. She reviewed the performance, growth, strengths, and opportunities for growth for San Pedro, Lotspeich, Robert Driscoll, Seale Jr. High School, and Robstown Early College High School. Also, she reviewed the district's actions and End of Course Exams for RECHS and Salazar Crossroads Academy. In, December they received scores for Algebra, Biology, and US History. As soon as they receive the scores for English I, and English II from TEA, she will share them with the Board. The administration has embarked on learning opportunities every Wednesday at the Education Service Center until February 2, 2022.

#### SUPERINTENDENT SCORE CARD REPORT

Dr. Jose Moreno reported that they were ten students short of reaching the school district's projected enrollment of 2509. At the present time, there are 2491 students enrolled. The attendance rate for the third six weeks was 87.7%. He also reviewed the discipline and attendance letter count for the third six weeks for each of the campuses. The administration has reached out to Calallen for help on the process that they have implemented on student recovery and to the Robstown Housing Authority. The Robstown Housing Authority was committed to helping the school district to encourage the students to go to school.

#### MAINTENANCE AND OPERATIONS UPDATE

Mr. Leeroy Gonzalez presented a plan of action for the Maintenance and Operations Department. He reported that they are having weekly meetings to review the results of the work orders in the new system. The new system has been in place for two weeks, and the employees check the work orders on their phones or on the computer in the hallway on a daily basis. Out of 193 work orders from January 3-7, 2022, seventy have been closed. Bottle water coolers have been installed at all of the campuses, the gym floors have been coated and re-varnished, and the scoreboard boards are working properly for the baseball and softball fields. A training has been scheduled for January 17-21, 2022 for all campus secretaries and administration on Eduphoria. Baseball season will start next Friday.

#### DISCUSS FINAL MODIFICATIONS TO CONTRACT FOR ENGINEERING SERVICES WITH WHEATON ENGINEERING FOR THE SCHOOL DISTRICT'S WELDING LAB PROJECT

Dr. Jose Moreno presented, to the Board, one contract with two different components for the school district's welding lab project from Wheaton Engineering for their review. The first component was the standard master agreement, and the second component was the service order agreement. The contract presented was the final contract.

7J COVID PRESENTATION AND UPDATE  
Dr. Jose Moreno presented a brief update report on how the school district is operating efficiently in helping the school district employees because it could change again with reports coming in regularly from TEA and the CDC. He reviewed different scenarios that the school district would be following in reference to COVID-19. Also, he presented a list of COVID-19 cases that they have had thus far and are posted on the school district's website for the public to view. At this time, it is highly recommended for students and staff to wear a mask even though it is not mandated.

7K SUPERINTENDENT UPDATES  
Dr. Jose Moreno reported that Diana Silvas, Lorena Ceballos, and himself will be attending the TASA Midwinter Conference at the end of the month. He has called for a Special Board Meeting/Finance Board Workshop on January 18, 2022, at 6:00 p.m. The 17<sup>th</sup> was a holiday so the meeting was changed to the 18<sup>th</sup>.

7L BUSINESS OFFICE UPDATE  
Mrs. Vanessa Riggs reported that she was still working on some of the items that she has presented over the last two months. In December, they talked about using the Covid-19 School Health Support Grant monies to purchase air-purifiers. They issued the RFP, the bids were due on January 4, and they received eight proposals. A recommendation would be presented at the Finance Board Workshop. In addition, they will also talk about ESSER. She has already submitted the RFP for Food Service for the 2022-2023 school year. At this time, she has not received any news from TEA.

10A DISCUSS AND CONSIDER APPROVAL OF RISD ANNUAL FINANCIAL AUDIT REPORT FOR SEPTEMBER 1, 2020, THROUGH AUGUST 31, 2021  
Mrs. Vanessa Riggs reported that the school district's audit had been completed, and she had great news as far as the General Fund and Fund Balance. Mr. Bill Vaughan with Armstrong-Vaughan & Associates reported that his job was to give an opinion, and his opinion was good on the audit. He was also to look into any non-compliance, and there were none. The audit did not have any significant findings or major findings. The report that will be forwarded to TEA had some minor things for the school district to consider. They were able to add \$2.1 million into the General Fund because of the stimulus monies, so the General Fund now has \$11.2 million. The General Fund rule is to have between three to six months in the reserves, and the school district has five months at this time. The school district would be very healthy if they were at six months. Also included in the audit report is a projection for the FIRST rating report. He is projecting an A for the school district. The school district had improvements in the books compared to last school year. After discussion, Dr. Jose Moreno recommended approving the Annual Financial Audit Report for September 1, 2020, through August 31, 2022.

If an employee did not use the ten days from August to December, they now have until the end of June to use them if needed. If an employee is not vaccinated, they don't qualify. The resolution also includes a religious exemption.
