Review of Current Performance on Investments


The attached graphs and data compare the rates paid on the investment pools utilized with the rate for the 13 and 26 week T-Bill auctions. A distinct advantage of the investment pools is that investor funds are very liquid. Money can be transferred overnight either in or out of pools. Multiple governmental investment pools are utilized to diversify the investments. Additionally, to increase interest earnings the District has invested in Certificate of Deposits (CD) through a program offered by TexasTerm. The interest rates received on the CD's are provided below and exceed both the 13 and 26 week T-Bill rates. The interest rates on the CD's range from .50% to .75% and are fully collateralized by FDIC Insurance.

You will notice a substantial spike in the T-bill rates the week of October 14th. This was due to investors being nervous about the prospect of the U.S. Government defaulting on its debt obligations due to Congress possibly not increasing the debt ceiling.


On average, the District received greater earnings from its portfolio than it would have from investing in 13 and 26 week T-Bills.
