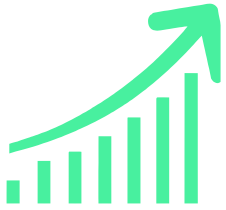

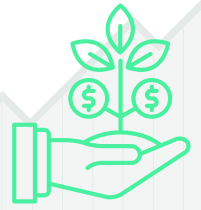

NOTABLE 2025 ACHIEVEMENTS:

- Worked with Capital Steel & Wire to renovate their facility. Total investment: \$1.46 million, 10 new jobs.
- Assisted Avalon in a building expansion for increased manufacturing space and acquisition of land for future development. Total expansion investment: \$1.28 million, 10 new jobs, 100 jobs retained.
- General business assistance to area manufacturers and agribusinesses, especially in regard to expansion assistance, financing, and employee development.
- Submitted West Hoffman Road for Michigan Ready Site status to increase visibility of the site for potential developments.
- Construction began on 311 E. Superior St. (mixed-use Brownfield in downtown Alma): \$3.1 M. Expected to be completed Q4 2025.
- Achieved a clean financial review with no material modifications in FY 2024.
- Administered Master Plan draft process, expected to be complete in Q4 2025.
- Supported talent development programs: Gratiot Young Professionals Network, Mid-Michigan Region 40 Under 40, CMMA Emerging Leaders, and Coming Home Talent event.
- Participated in regional studies addressing housing and childcare needs in the area.
