1. Opening and Call to Order Dale Freeman

Chair Freeman called the Special Board Meeting to order at 8:01 am

- 1.1. The group recited the Pledge of Allegiance.
- 1.2. Chair Freeman reminded all in attendance the meeting is being audio recorded.

2. IMESD 2019-20 Local Service Plan Mark Mulvihill

Mr. Mulvihill thanked Mr. Fritsch for the opportunity to share the 2019-20 Local Service Plan (LSP) with the Board. The InterMountain ESD (IMESD) is legislatively mandated to provide four core areas of service to students and schools: 1) Programs for children with special needs, 2) Technology Support, 3) Instructional Services, and 4) Administrative and other services. Mr. Mulvihill started with the LSP map, covering four counties and eighteen component school districts, noting the color key depicts the funding mechanisms. The LSP is an annual process, in which the districts determine the allocation of the General Fund resources, monies paid to the ESD by the districts, equitably across the region. The Speech/Language Program and School Psychology/Behavior Services receive the biggest portion of the funds. Mr. Mulvihill shared the LSP is based on a state K-12 biennium allocation of \$9.1 billion, which is a growth budget for IMESD. The IMESD will focus on the addition of a certified special education coach and the expansion of Wraparound Services, specifically flexible nursing services.

3. **CTE Update** *Curt Thompson*

Mr. Thompson was excited to report the new agriculture teacher, Kylee Jensen, and Marty Campbell are working very well together, sharing the teaching load and the students are benefitting from the strong partnership. A huge dividend is shown by 80% of the freshman Ag students have an SAE (Supervised Ag Experience) plan in place, which is one facet of a comprehensive Ag program needed to pursue a state degree. This is a significant increase from 20% participation in the past. Mr. Thompson showed a PowerPoint presenting highlights from each of the four CTE Pathways: 1) Agriculture Science & Mechanics Pathway, 2) Culinary Arts Pathway, 3) Digital & Media Arts Pathway, and 4) Industrial & Engineering Systems Pathway.

4. Fall Behavior Screening Data Julie Smith

Dr. Smith shared with the Board a practice that happens twice yearly for every student in the elementary schools, which is a Student Risk Screening Scale done by the teachers. This is part of the Multi-Tiered Systems of Support

(MTSS) that Pendleton School District provides. The information is used to determine those students that may need additional support and the health of core programs around social-emotional learning, reading, and math. Dr. Smith reviewed the fall screening data that was included in the board packet.
