WCJC Proposed Tax Rate

**RECOMMENDATION:**

Recommend the Board of Trustees vote to consider the proposed tax rate of \$0.13684/\$100 valuation and set the date of September 15, 2020 to have the final vote on the rate.

**BACKGROUND/RATIONALE:**

Cindy Hernandez with the Wharton County Tax Office has calculated WCJC's No-New-Revenue tax rate. Her calculations indicate that our No-New-Revenue tax rate will be \$0.13684/\$100 valuation, which is \$0.00250 less than our current rate of \$0.13934/\$100 valuation. Changes to the Texas Truth-in-Taxation now requires the Board of Trustees vote on the proposed rate, a publication be published in the local newspapers, and the official vote occur prior to September 30<sup>th</sup>.

BACKGROUND/RATIONALE:

Clint Himmelfarb with the Wharton County Tax Office has calculated WJC's No-New-Business tax rate. His calculations indicate that our No-New-Business tax rate will be \$0.13689-\$100 valuation which is \$0.0079 less than our current rate of \$0.14479-\$100 valuation. Changes to the Tax Code in 2017 allow the Board of Trustees to vote on the proposed rate. A publication be published in the local newspaper and the official vote occur prior to September 30<sup>th</sup>.
