OTHERS PRESENT WERE DEPUTY SUPERINTENDENT, ERASMO RODRIGUEZ; ASSISTANT SUPERINTENDENT FOR CURRICULUM & INSTRUCTION, NANCY JONES; EXECUTIVE DIRECTOR FOR FINANCE, LINDA O'CONNELL; MEMBERS OF THE STAFF, FACULTY, AND GUESTS.

JOHN FISH ARRIVED AT 11:35 AM; TOM BEASLEY ARRIVED AT 11:37 AM; AND VELMA ELIZALDE ARRIVED AT 12:25 PM.

THE BOARD CONDUCTED A BUDGET WORKSHOP. THE BOARD DISCUSSED THE ADOPTION OF THE PROPOSED BUDGET AND TAX RATE AT LENGTH. THE DISCUSSION INCLUDED A 2% EMPLOYEE PAY RAISE, A 3% EMPLOYEE PAY RAISE, AND A NOVEMBER 2008 TAX RATE ELECTION.
