Background:

Snelling Alaska is the programmer who assists with the interface of the Visual Iñupiaq Vocabulary Assessment (VIVA) computer program. This contract is for the purpose of providing fixes and support for the VIVA computer program; expanding the program by providing additions to monitoring reports and automatic testing and updating the program to run with updated Adobe software. VIVA utilizes Adobe Flash in order to keep the program interactive and usable and with Adobe discontinuing its use of Adobe Flash, VIVA will need to be updated in order to not remain dependent on Adobe Flash in order to remain interactive and usable in all classrooms.

Length of Contract:

The length of the contract would be from March 1, 2021 through June 30, 2022.

Funding Source and Purchase/Contract Amount:

This contract would come out of the Iñupiaq Education Department Professional & Technical budget (Account Code: 100.200.120.000.410) in the amount of and not to exceed \$18,150.00.

The District has worked with Snelling Alaska over the years as the programmer for the creation and maintenance of the VIVA application.
