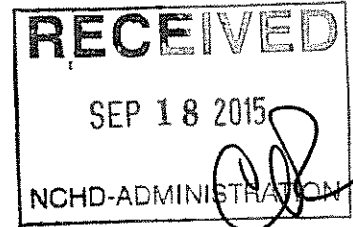

MEETS:

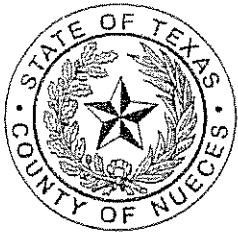
