

FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This First Amendment to Professional Services Agreement (this “Amendment”) is effective as of September 30, 2025 (the “Amendment Effective Date”), by and between H2U Wellness Centers – PISD, PLLC d/b/a Goose Creek ISD Wellness Clinic, a Texas professional limited liability company (“Contractor”) and Goose Creek Consolidated Independent School District, a Texas public school district (“Client”).

WHEREAS, Contractor and Client entered into that certain Professional Services Agreement, effective as of October 1, 2024, pursuant to which Contractor provides certain clinical and management services to Client (the “Agreement”); and

WHEREAS, the parties desire to extend the term of the Agreement, as set forth herein.

NOW, THEREFORE, for and in consideration of the mutual covenants herein contained, and for other good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, Contractor and Client hereby agree to amend the Agreement as follows:

1. Section 3.1 of the Agreement is hereby amended to extend the term of the Agreement through September 30, 2026, with the option to renew for three (3) additional one (1) year terms upon the mutual written agreement of both parties.
2. Section 12 of the Agreement is hereby amended to add the following notice address for Contractor:
