Press Release

The Public Workers' Compensation Program (PWCP) Board of Trustees recently declared the fifth consecutive excess contribution refund (ECR) for districts participating in PWCP, including \$42,098 this year directly to Aledo ISD. Since joining PWCP Aledo ISD has received a total of \$378,035 in excess contribution refunds.

This ECR, totaling \$800,000 applies to PWCP members who were participants from September 1, 2003 to August 31, 2006. In 1992, PWCP began offering workers' compensation coverage to schools throughout the state to minimize cost and provide a safer and healthier environment to PWCP members. Since then, the total amount of ECR's approved to PWCP members exceeds \$6,200,000.

For more than 18 years, Edwards Risk Management, Inc. has partnered with Aledo ISD through the PWCP to bring about risk management solutions to prevent employee injuries and return employees back to work. Together they have created a more productive workforce, while adding nontraditional services and benefits such as; loss control training, employee incentives, employee assistance programs, safety and security reviews, student safety hotline, and an employee wellness program. Without the efforts of Aledo ISD employees, students, and community patrons, this could not have been possible. Aledo ISD and PWCP are proud of this success and the opportunity to return dollars directly back to education.
