BUILDING RELATIONSHIPS WITH LEGISLATORS

Building a strong relationship with your local legislator can have a tremendous impact on your school district.

ESTABLISHING RELATIONSHIPS

- Reach out to legislators early before the session — to discuss key district priorities and the state of your schools.
- Strive for ongoing, regular communication be a familiar voice and face to them.
- Know your legislators' backgrounds: Don't assume they are education policy or finance experts. What committees do they serve on? Are they parents? What is their experience outside of the Legislature?
- Communicate on their terms ask your legislators which methods of communication they prefer: texting, e-mails, phone calls, meetings in person, school visits during legislative breaks, etc.

MAINTAINING RELATIONSHIPS

- Inventory your relationships: By knowing your legislators' committees and issues of interest, you can identify who on your team can help make solid connections.
- Give them a "heads up" on positive and negative news before it is released publicly. This will help them advocate for you.
- Keep social media positive. Always.
- Know the impacts. Be able to let legislators know how proposals may affect your district.
- Say THANK YOU whether on social media, your district newsletter, a public acknowledgment or a personal note, legislators appreciate recognition of the impact of their work.

COMMUNICATING WITH LEGISLATORS

- Share the AMSD platform and your district priorities.
 Know your data and share your district's information to back it up.
- Develop consistent
 messaging themes for
 leadership, school board
 members, principals
 and others to deliver to
 legislators.
- Keep interactions positive and clear.
- Repeat priorities and needs in different delivery forms (meetings, school tours, e-mails, handouts) and from different stakeholders.
- If your legislator introduces a bill on your behalf or one your district supports, offer testimony and handouts to support the bill.
- Ask your legislators if they are interested in establishing a regular check-in time.



- Add legislators to your newsletter and press release distribution.
- Prioritize: Be concise; don't oversaturate them with too much information.
- Make sure information is relevant and timely.
- Invite legislators into your schools and classrooms to observe and participate in various activities or unique programs.
- Your concerns and messages will be better received at the end of session during final budget negotiations if you've established an ongoing rapport/relationship.



EFFECTIVE TESTIMONY

- Plan on very brief testimony – often limited to 2 minutes.
- Have your testimony prepared in advance.
- Be clear and concise, try to avoid repeating previous testimony.
- Know your position:
 State whether
 you are testifying
 in support of, or
 in opposition, to
 legislation.
- Your testimony is personal. Provide your specific examples.
- Review the list of committee members and learn their backgrounds.

COMMITTEE LOGISTICS AND RULES



- Legislative committee staff is responsible for setting committee agendas for each hearing and will establish guidelines for testimony and the speaking order of testifiers.
- Work with AMSD if you plan to testify on a specific piece of legislation. AMSD can help prepare and submit testimony or handouts.
- Start your testimony when directed by the chair with "Thank you, Madame/Mr. Chair." Identify yourself and your role with your school district.
- Testimony and Q&A is moderated through the chair of the committee.
- Don't guess: It is better to say you will research the issue and provide the information to the committee as soon as possible.
