## INTERGOVERNMENTAL AGREEMENT BETWEEN SCHOOL DISTRICTS

The purpose of this agreement is to form a cooperative high school athletic program in girls' soccer between Athens Community Unit School District #213, hereafter referred to as Athens, Greenview Community Unit School District #200, hereafter referred to as Greenview, and, Illini Central Community School District #189, hereafter referred to as Illini Central. This agreement is made following the provisions of By-law 2-030 of the Illinois High School Association (IHSA) and shall be in effect for the terms of the 2025-2026 school years and beyond.

**Personnel:** Necessary coaching personnel will be furnished and compensated by Athens. Suppose the number of student-athletes' dictates adding an assistant coach. Illini Central, and Greenview may be asked to assist in paying an assistant coach.

**Insurance:** Each district shall be responsible for the insurance coverage of its student-athletes according to its policies. Individual student-athletes must comply with the insurance requirements of Athens' athletic policy.

**Liability:** Liability for student-athletes shall rest with their home district and shall be determined, if necessary, as the circumstances dictate under the law.

**Facilities:** Athens High School shall be used for the practice session and home games. Athens assumes the usual responsibilities associated with providing facilities.

**Transportation:** Greenview and Illini Central will bear the responsibility of transporting its student-athletes according to the district's cooperative sports transportation policy. Athens will provide transportation to away games from Athens High School to the game and back to Athens High School. Greenview and Illini Central will bear the responsibility of transporting its student-athletes according to the district's cooperative transportation policy. Every attempt will be made to facilitate travel from Greenview and Illini Central by utilizing Athens' busses to away games.

**Equipment** - Equipment, including uniforms, will be furnished by Athens. Practice clothes are the responsibility of the individual participants. Supplies and equipment that Greenview and Illini Central may own that can benefit the program will be utilized upon agreement between the principals.

**Eligibility:** Student athletes' eligibility shall be determined per Athens' athletic policy. Greenview and Illini Central may hold their student-athletes to a higher standard.

Greenview and Illini Central shall submit by email or phone to Athens High School the eligibility status of their student-athletes each Monday morning during the season. Eligibility runs from Monday through Sunday during the season.

**Conduct:** All student-athletes will be held to the standards of conduct outlined in Athens' athletic policy. If a given rule is more restrictive in the Greenview and Illini Central athletic policies, student-athletes from Greenview and Illini Central will be held to their school's standard.

**Fees:** Student-athletes from Greenview and Illini Central will pay Athens the regular athletic fee required of Athens student-athletes. This is subject to change but currently stands at \$75. Also, each school is subject to the IHSA fees due if applicable.

**Awards:** At such time as awards may be presented after the season (placards, letters, numerals, patches, pins, certificates), they shall be awarded to any participant that meets the coach's criteria.

Greenview and Illini Central may choose to award their school color letters, etc., at their own expense.
