**BACKGROUND INFORMATION:**

We are requesting approval to increase the full price meals as follows for the 2018-2019 SY to comply with the Meal Equity Pricing regulation that stipulates full price lunch meals must provide the same level of financial support for the Food Service program as free and reduced price lunches. Required weighted average price for 2018-2019 is \$2.92.

37% of our student population will be affected by this change. The remaining 63% qualify for free or reduced price meals. We also request permission to increase the price of a la carte items to reflect current market changes.

The Federal Government continues to implement stricter nutrition standards for school meals that require more expensive whole grain, low fat, lower sodium food products. Breakfast continues the requirement of an additional fruit serving and both breakfast & lunch must offer 100% whole grains with the possibility of lower sodium levels to Target Level II for the 2018-2019 SY. We estimate that our food costs will increase between 1.5-5%.
