2026-2027 AISD Staff Compliance Training DMA (LOCAL)

Argyle ISD requires annual compliance training of staff in accordance with the [TEA Continuing Education and Training Clearinghouse](#) as outlined in SB 1267. Per DMA (LOCAL), the local school board shall annually review the SBEC Clearinghouse, approve the required professional development plan, and note any differences in the District's professional development plan from the clearinghouse requirements. Argyle ISD **does not** differ from the Clearinghouse-recommended training.
