Other Items

Construction Update

Copeland Manor – working on getting deductive change orders processed. E.B. Shands and Yonan are in the court system. Approximately owed \$600,000 of about \$400,000 is owed after deductive change orders. Flooring was tested in July and within the tolerances, with the exception of a couple areas which require more blocking. Mr, Graves has inquired to NFMA to discuss the testing results per the specifications. The fix per NFMA is to remove blocking, flooring firm needs to fix it and then retest to see if it makes the 90% threshold.

Rockland School – Mr. Graves showed to video and pictures of the Rockland projects. Discussed relocation of sanitary sewer per Village request. Meeting weekly with contractor and Jeff to plan for the next week. Contractor has worked well with the District in planning movement around site.

Superintendent Update

Mr. Vickers discussed the new superintendent hiring process. The Board should invite several search firms to be provide documents and presentation. There are four or five groups, BWP, Hazard Young Attea, School ExeConnect, Ray & Associates and IASB. Bring them in October for a Special Board Meeting. The goal is to conclude the process a year from now.

Dr. Schumacher gave the Board the presentations for this year at the Board Meeting.
