2910-2011 BUDGET

Member Strahan moved to adopt the 2010-2011 budget as approved by the Budget Committee and Member Litak seconded.

Superintendent Huber-Kantola stated that adopting this budget does not mean that we are going to spend to this budget. This budget was made before we learned that the district will not have the revenue to support this level of a budget. So, we may adopt this budget but by no means unless something happens Federally or in the State Legislature are we going to spend to this level of this budget.

Board Chair Weaver commented that is probably the reason for the lack of discussion and questions tonight. We don't know what the future is going to hold for the district financially. By law, we have to adopt a budget by the end of June and a lot of work has gone in to this budget even if it may not prove to be a realistic one.

Member Strahan expressed his displeasure in that we are required by law to have a budget adopted by a certain date, knowing that this probably won't be the budget we are working with due to the fact that we get the numbers from the state so late in the year—and they are constantly changing.
