Dr. Judy Castleberry, Conservator, directed the Board of Trustees to approve the Local District of Innovation Plan as recommended by the administration.

4. Discussion and possible action to approve the consolidation of the Athens Elementary student enrollment with Carrillo Elementary and Price Elementary and the approval of the consolidation of the Kazen Middle School enrollment with Zamora Middle School and Dwight Middle School starting with the 2017-2018 school year and approve the closure of the Alternative School program.

Dr. Saavedra, Superintendent, Delinda Castro, Chief Academic Officer, and JC Zamora, Chief Financial Officer, were called to present and answer questions related to this item.

Mr. Ybarra made a motion to approve the item as follows:

- 1. To close the alternative school and partner with other San Antonio school districts for those services;
- 2. To temporarily suspend operations at Kazen Middle School and Athens Elementary School beginning with the 2017-2018 school year;
- 3. To consolidate current student populations of Athens Elementary with Carrillo Elementary and Price Elementary and consolidate current enrollment of Kazen Middle School with Zamora Middle School and Dwight Middle School; AND

- 4. To direct the Superintendent to take the following actions:
- a. Convene a committee of stakeholders named by the Lonestar Governance Committee by May 17, 2017, to develop a long-term plan for facilities use that will support student outcome goals adopted by the Board and grow enrollment;
- b. Publish and disseminate by paper copies and send home with students a transition plan that includes a summer visit to intercepting schools, identifies a single point of contact for questions, and explains transportation options;
- c. By May 1, specify by budget function, where and how the savings from temporarily suspending operations at Athens Elementary, Kazen Middle School, and the Alternative School Program will be used to support the South San Antonio ISD Board's student outcome goals; AND
- d. Provide a report by February 1, 2018 that (1) summarizes community feedback throughout the past year and during the course of the new committee's work and (2) provides multiple options for repurposing Kazen and Athens for uses that reflect community feedback, serve South San students directly, advance the Board's student outcome goals, and grow enrollment.

Mrs. Flores seconded Mr. Ybarra's motion, and the Board of Trustees voted 4/3 to approve the item as presented. <u>Motion passed.</u>

Mrs. Guerra made a sub motion of an option 5 to 1.) Delay the closures of Kazen and Athens for 1 year, and the Alternative School Program to close the Hernandez Learning Center and transfer those students into the Administration Office to establish a school of choice at Hernandez. 2.) The Board and Superintendent start working on cost saving measures at each campus by adjusting utilization of buildings. 3.) The Board and the Superintendent begin the process for bond election and TRE by November or May of next year. 4.) The Superintendent begin review of each school attendance zone, have recommendations for the Board by January 2018, and notify parents of this by the Spring of 2018. 5.) The Board and Superintendent think outside the box to propose programs which will make us competitive with charter schools and other public school districts by forming a citizen's advisory committee to study and recommend schools of choice, bond, TRE, campus and facility utilization. 6.) The Board, Superintendent, and citizen's advisory committee present bond and TRE recommendations to the community at meetings throughout the district like we did with this closure, at the same time the Superintendent will present his recommendation for consolidation of schools and other educational functions if the bond and TRE are not approved and by doing this giving the

community the choices, Mrs. Prado seconded, and the Board of Trustees voted 3/4 by a show of hands on the sub motion. Motion failed.
