B. Approval of request for Competitive Sealed Proposals (CSP) as the solicitation method of procurement for the Construction of a New Elevator for the Football Stadium at the Student Activity Complex

Roberto J. Santos – I had Mr. Rangel get in touch with the Engineers/Architect Kell Munoz to be able to work on the new elevator for the SAC. We want to come to the board and make a recommendation on the method that we need to solicit our proposal.

Cordy Flores-Jackson – Staff recommends a competitive sealed proposal as a method of procurement for this project. Prior to any construction projects government code 2267.056 request that the board solicits a method that best meets the needs of the project. Our construction department has stated that CSP would be the best method for this project.

Juan R. Ramirez – Will the other elevator be functioning still?

Roberto J. Santos – We want to fix it and have it there as a back up, but at this point we are having major problems with it. It's a different kind and Mr. Rangel will share with you the different kind of elevator we need.

Pat Campos – As long as it goes up and down.

Mr. Enrique Rangel – Good Evening Board Members, Mr. Santos The current elevator that is located at the SAC is functioning in a method that is called the piston hydraulic system. It is slower than the typical cable operated elevator. The one we are looking at installing is a gear or a cable elevator that would be faster and more reliable.

Juan R. Ramirez – Is there any way we can work out with the company that the present elevator we have be able to work with a different method?

Roberto J. Santos – I think the problem is and Mr. Rangel has shared this with you that it's a piston style elevator. I'm not sure that they would be able to use different pistons to make it go faster.

Enrique Rangel – To answer your question that adjustment has been made already. It is pretty much going as fast as the system allows. What happens is that it takes a long time for the hydraulic system to get ready to start lifting the elevator. It does have adjustments, you are correct, but we have made those adjustments already.

Judd Gilpin - It actually does not work some of the time as well, right.

Roberto J. Santos – Recently, I think this last month/month and a half it has gone down. I think we need to put this on the fast track and I know we have gotten some of the service people to fix it. Come Friday we start having issues with it again of course it will take a little time. I hope that maybe by December as the track season comes around and soccer hopefully we will have something there that will be able to work

Judd Gilpin – Is there an obligation to have the elevator functioning with ADA requirements?

Enrique Rangel – Correct, yes Sir. That's why it's critical for us every time it malfunctions to immediately get the service company to get it back in operation.

Judd Gilpin - Do you have to notify them every time that happens?

Enrique Rangel – No, there is no state requirement to notify them, unless it's going to be out of operation for more than 30 days. We need to notify and find alternative methods of accommodations to any ADA requirements.

Pat Campos – Is it possible that the kids that are there working the games that every time they open the door for people they tend to hold it

open until that person arrives. Does that have anything to do with it not working?

Enrique Rangel – I think basically it's the wear and tear on the equipment. That type of elevator ever since it was installed has been very slow and not an adequate elevator for this height requirements. We have the same elevator at the baseball/softball stadium and for a small height in elevation.

Rick Rodriguez - Are they cable?

Enrique Rangel – No, they are piston since the height requirement is not much. It works fine. Krueger Field has the same type (piston) and it works well. There at the SAC we need to go with cable which is meant for higher number of stories more reliable and much faster. As Mr. Santos mentioned we will have this as a backup.

This Public Hearing is to let the Board and the Public know that according to this 82nd Legislative Session regarding Senate Bill 1 we have to have a public hearing to continue taxing goods in transit. We have always taxed our goods in transit at United ISD as well as our sister district does. Also, they did change some language and the code so that is the reason why we have to adopt another resolution. It would be a potential loss of about 2.9 million dollars in tax revenue to the district if we did not choose to tax our free port goods.

Juan Ramirez – I was at a conference in Austin on the 82^{nd} Legislative Session. We were able to talk to TEA and ask the state lawmakers to allow taxation and to raise it within the limits of the law.

Rene De La Vina – Good evening, members of the board my name is Rene De La Vina President of TSTA and I am speaking on Item IX. A Consider Resolution to join lawsuit concerning the Texas school finance system and potential litigation to protect the taxpayers and school children of Texas. I feel that you should have a lawsuit against the State of Texas for the lack of funding. As you know when it comes to accountability that has not changes. Now that STARS is coming around it's going to be more demanding on our teachers and for everyone, but yet they keep cutting funds more and more. Now speaking as a taxpayer, I believe the State of Texas has been cutting so much that they have been putting a burden on the local tax payers because they are not paying their fair share of funding for our children.

On behalf of our children I want to ask you to file and join the lawsuit. I believe there are 200 school districts that have filed. I think this a good lawsuit. They did violate the constitution as for as lack of funding. Now speaking as a Board Member we have the same problem and are looking into filing a lawsuit against the State of Texas for their lack of funding. We state about 10 years ago where we had about 54% funding and were down to 32%. We go up in taxes, we go up in tuition and they keep getting upset. "Why are we going up in taxes/tuition?' Again, it's the same thing. They keep cutting, cutting and cutting, but again we're not helping. Again, let's go ahead and file for the lawsuit and get the money for our children.

C. Approval of Resolution to Tax Tangible Personal Property in Transit

Mrs. Norma Farabough read the resolution into the minutes.

A RESOLUTION OF THE UNITED INDEPENDENT SCHOOL DISTRICT TO TAX TANGIBLE PERSONAL PROPERTY IN TRANSIT WHICH WOULD OTHERWISE BE EXEMPT PURSUANT TO TEXAS TAX CODE, SECTION 11.253

WHEREAS, the 82nd Texas Legislature in it First Called Session has enacted Senate Bill 1, including Section 48.02 thereof to take effect on October 1, 2011, which would amend Texas Tax Code § 11.253 to exempt from taxation certain tangible personal property that is acquired in or Imported into this state to be forwarded to another location in this state or outside this state; is stored under a contract of bailment by a public warehouse operator at one or more public warehouse facilities in this state that are not in any way owned or controlled by the owner of the personal property for the account of the person who acquired or imported the property; is transported to another location in this state or outside this state not later than 175 days after the date the person acquired the property in or imported the property into this state; and does not include oil, natural gas, petroleum products, aircraft, dealer's motor vehicle inventory, dealer's vessel and outboard motor inventory, dealer's heavy equipment inventory, or retail manufactured housing inventory ("goods-intransit"), which property has been subject to taxation in the past; and

WHEREAS, Texas Tax Code §11.253 as amended allows the governing body of a taxing unit, after conducting a public hearing, to provide for the continued taxation of such goods-in-transit; and

WHEREAS, the Board of Trustees of the United Independent School District, having conducted a public hearing as required by Section 1-n (d), Article VIII, Texas Constitution, is of the opinion that it is in the best interests of the district to continue to tax such goods-in-transit;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES FOR THE UNITED INDEPENDENT SCHOOL DISTRICT THAT:

The goods-in-transit, as defined Texas Tax Code 11.253(a)(2), as amended by Senate Bill 1. enacted by the 82nd Texas Legislature in its First Called Session, shall remain subject to taxation by the United Independent School District.

RESOLUTION AND CONSENT OF THE BOARD OF TRUSTEES OF THE UNITED INDEPENDENT SCHOOL DISTRICT

The Board of Trustees ("Board") of the United Independent School District ("District") does hereby consent and agree, pursuant to Section 11.151 of the Texas Education Code, that the following resolutions be, hereby are, adopted by the Board:

WHEREAS the Board believes that the presently existing statutory system for the financing of public education in Texas ("Finance System") has and will continue to impair, unless significantly reformed, the education available to the students within the District as well as the ability of the District to provide an appropriate education to all students within the District; and

WHEREAS the Board deems it in the best interest of the District to seek an end to such impairment through the judicial system; and

WHEREAS the Board deems it in the interest of the District to participate with other school districts to retain the Equity Center to challenge the Finance System; now, therefore, be it

RESOLVED, that the District is hereby authorized to join with other school districts to participate in litigation to challenge the existing Finance System; and be it further

RESOLVED, that the retention of the Equity Center be and hereby is authorized and approved for that purpose according to an expenditure not to exceed \$1 per WADA to join together with other Texas public schools, taxpayers and parents as an unincorporated association for the purpose of speaking with one voice in the litigation of public school finance matters essential to the fair treatment of Texas taxpayers and public school children and be it further

RESOLVED, that the Equity Center, and hereby is, authorized, empowered, and directed to file and prosecute a lawsuit challenging the presently existing statutory system for the financing of public education in Texas; and be it further

RESOLVED, that the expenditure of public funds by the District be and hereby is authorized and approved for that purpose.
