## Facilities Update - Solar

- The District, as you know from previous presentations, is very interested a comprehensive project analysis to explore the possibility of implementing solar energy solutions in our school District. We have also included support for solar projects as part of our legislative platform and lobbying efforts. Prior funding opportunities benefitted smaller districts and districts in the metro area more significantly than those that Duluth would qualify for. We have been working with several supportive community members as we explore our potential options.
- We have narrowed the project decision to one of two options; either a solar canopy or rooftop solar option at our District Services Center. In addition, there is a solar advocacy student group within our District that has also mentioned a solar garden option at our Lincoln Park Middle School site. As we move ahead, we would like to evaluate which of these projects would be the most beneficial and feasible to do further analysis.

# Facilities Update - Lowell

- We are working with St. Louis County and area stakeholders to address the traffic issues at Lowell Elementary School.
- We held an information and input meeting last night. We received a great deal of input and are currently assessing as we consider next steps.
- We will be meeting soon with county officials to determine next steps.

### **Juneteenth Celebrations**

- Tomorrow, Duluth Public Schools will be closed as we observe the Juneteenth holiday.
- This is the second year that we have formally recognised the holiday and did so prior to legislation requiring us to do so.

# **Budgeting Reminder**

- Phase I would focus on addressing needs for the coming year.
  - 2.3 M in non-personnel budget reductions
  - Proposed usage of assigned fund balance (with board approval) from property sales to create an "off ramp" from ESSER spending for 2024-25
- Phase II will involve a comprehensive, collaborative process involving the board and other stakeholders. We intend to complete the process in early winter of 2025 to allow for 2025-26 budget planning.

## **Budget Next Steps**

- The 2024-25 Budget will be brought for approval tonight.
- Our process and timeline for identifying 2025-26 budget reductions and reallocations is nearly complete and will be shared with the board in July
- We would like to hold an additional budget retreat with the board in August
- Additional steps in the process would take place throughout the fall with recommendations coming to the board prior to second semester.
