We meet all the legal publication requirements under state statutes. Our circulation is audited by Verified Audit Circulation, an independent firm.



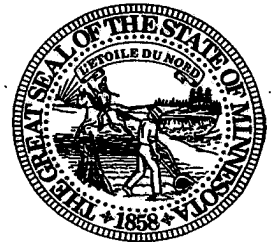


