

## Sheridan School District School Resource Deputy Report

March 1<sup>st</sup>, 2015 through April 9<sup>th</sup>, 2015

School Related Incidents = 16 total

<b>Location</b>	<b>Type of call</b>	<b>Summary of Incident</b>
Faulconer Chapman School	Student Threat	9 year old student made a statement wanting a gun to shoot himself. He also grabbed scissors in class and told the teacher he wanted to leave the room. A threat assessment was completed on student and a safety plan was put in place.
Sheridan High School	Driving complaint	Sheridan City Public Works reported a reckless driver caused minor damage near the Sheridan fishing pond. The driver was a student on lunch break. Student reported a malfunction with his vehicle and he went and repaired minor damage that was caused.
Sheridan High School	Theft	A 14 year old student reported someone took \$5.00 off her desk when she went and talked to another student in class. She did not realize it was missing until her next class. Several students were interviewed and the money was not located.
Sheridan High School	Parent contact	A parent contacted me and told me they are concerned about their daughter's behavior. We discussed options.

Falconer Chapman School	Child abuse/ Neglect	A teacher reported a possible Child Abuse/ Neglect regarding a 6 year old male possibly being locked out of his residence and being locked in his room at night. DHS Child Welfare and I investigated the incident and concluded the allegations were unfounded.
Falconer Chapman/ Sheridan High School/ Sheridan All Prep	Attendance/ Truancy issues	I delivered over 9 attendance letters and contacted parents regarding their student's attendance at the mentioned school. Meetings were set and plans made to keep them in school.
Sheridan High School	Sexual Harassment	An 18 year old female student reported she was sexually harassed by a 14 year old male while exiting a door from the gym after an assembly. The incident was investigated and sent to the Yamhill County Juvenile Office for disposition.
Sheridan High School	Theft	A 16 year old female reported 2 rings were stolen or missing from her gym locker after she accidentally left them out after P.E class. She saw the rings on another student and the student was contacted. The student with the rings said her sister found them in the locker room and gave them to her. The rings were returned to the owner. No charges were filed.

<p>Falconer Chapman School</p>	<p>Disturbance/ possible child abuse</p>	<p>A 10 year old student was suspended from school and their mother and grandfather came to pick him up. The student became defiant and ran from the grandfather causing the grandfather to become physical with the student to gain control of him to remove him from the school. The incident occurred in the main entry to the school and several staff and students witnessed it. There was concern for the child's welfare/ safety after the grandfather made comments while leaving the school. A Polk County Sheriff's Deputy and I went to the child's house to make sure he was safe and not injured.</p>
<p>Falconer Chapman School</p>	<p>Threat Assessment</p>	<p>A 5<sup>th</sup> grade student wrote a note stating he wanted a gun to shoot everyone in the universe and then wanted a classmate to shoot him in the head and then have the classmate shoot himself in the leg. Parent was contacted and a threat assessment was completed. Parent is seeking counseling for student.</p>

Faulconer Chapman School	Assault 4 <sup>th</sup> Degree	A 13 year old male student punched a 14 year old student in the face with a closed fist during P.E class. The victim student suffered a bruise near his eye and a chipped tooth. Victim student had pushed over some mats the suspect was laying on which made him angry. The suspect was charged with Assault 4 <sup>th</sup> degree and lodged in Juvenile Detention.
Faulconer Chapman School	Weapon complaint	An 11 year old student was found in possession of a make shift sharp object. The student had removed the head of a tooth brush and carved the head to a point. The student had clothing at school and was planning on running away from home about a month prior.
Faulconer Chapman School	Fight on playground	A 7 <sup>th</sup> grade student had shoved a 1 <sup>st</sup> grade student to the ground after the 1 <sup>st</sup> grader tackled him at the feet and then struck him in the groin while they were playing.
Faulconer Chapman School	Fight in gym class	Two 10 year old boys caused injury to each other after one shoved the other boy and the boy kicked him in the groin. The boy that was kicked in the groin then bit the other in the upper arm.



Hwy 18/ mile post 33, Sheridan	Probation violation arrest	Assisted Deputy Park after suspect attempted to hide in a culvert along Hwy and then ran from Deputy Park. Suspect was arrested and taken to jail.
Hwy 18B/ Mile post 5, Sheridan	Runaway	Assisted Deputy Rex with a 15 year old female that ran away from a house in Willamina. She refused to get in vehicle and follow foster parent's instruction. Talked female into going with DHS/ Child Welfare to get other placement.
900 Block SE Sheridan Road, Sheridan	Warrant arrest	Assisted several other Deputies with arrest of 24 year old female. She was located and taken to jail.
SE Sheridan Rd/ SE Clark Street, Sheridan	Warrant arrest	Assisted in stopping a vehicle that had a wanted felon in it. Suspect was taken into custody without incident and taken to jail.
200 Block SW Harrison Street, Sheridan	Alarm	Residential alarm. Owner arrived and I was told it was a malfunction.
Grand Ronde Governance Center	Active Shooter table top exercise. (Training)	Participated in table top exercise with other agencies. Went well and learned some new ideas.
500 Block W Main Street, Sheridan	Welfare check	DHS/ Child Welfare requested welfare check on child. No one home.
Hwy 18/ Red Prairie Road, Sheridan	Motor vehicle crash	2 vehicle crash with injury. Assisted Deputy Rex, Park and Sgt. Whitlow.

Dayton High School	Unarmed response to active shooter (Training)	Participated with W.E.S.D Threat Assessment members in giving training to students regarding unarmed response to active shooter in school setting.
300 Block SE Sheridan Road, Sheridan	Alarm	Located alarm at vacant residence. Alarm was for some type of pump. Contacted Reality Company.
Hwy 18/ S Bridge Street, overpass	Suspicious person	Report of 20 year old male coming from under the bridge. Unable to locate.
1500 Block W Main Street, Sheridan	Suspicious vehicle	Owner of business reported vehicle had been left over night and abandoned. Owner arrived shortly after and removed vehicle.
100 Block E Main Street, Sheridan	Death Investigation	Assisted Deputy Park and Sgt. Whitlow with death investigation.
800 Block SW Bales Ave, Willamina	Domestic assault	Assisted Deputy Skaer with domestic assault investigation. Suspect was taken into custody and transported to the jail.
Hwy 18/ S Bridge Street overpass	Welfare check	Report of white female adult standing on bridge looking over railing at Hwy. Unable to locate on arrival.
Hwy 18 Mile post 35	Cover/ back up	Covered Trooper Davis on traffic stop after driver switched places with other person in vehicle.
900 Block SE Sheridan Road	Domestic Assault	Assisted Deputy Rex with domestic assault. Male adult forgot to take medications for mental health issues.

N Bridge Street/ NW Yamhill Street, Sheridan	Cold motor vehicle crash	Driver involved in non-injury, non-reportable crash wanted to report other driver has no insurance or driver's license.
Yamhill County	Training	Firearms training at range.
Hwy 18B/ Houser Road, Willamina	Traffic hazard	Found railroad crossing arm laying in roadway. Removed and contacted RR company to have fixed.
Willamina Elementary School	Attendance/ Truancy issue	Talked with principal Zimbrick about students with attendance issues.
1000 Block Willamina Creek Road, Willamina	Motor vehicle crash	Assisted Deputy Park and Deputy Casey with 1 vehicle roll over crash.
