Director Grindland proposed that the school district sell the Elementary/High School Building to the City of Rushford for \$100. The facilities committee will meet to discuss a plan for the building.

The city facilitated the moving of the school crossing flashing sign (from the old school) and provided man hours and equipment for the sidewalk project. The district is very appreciative of the city's assistance, cooperation and support of the sidewalk project.
