- **1. Call Meeting to Order:** Chairman Christensen called the board meeting to order at 7:02 p.m. with Vice-Chairman Lau, Trustee Stoor, Trustee Torgesen, and Trustee Erickson in attendance. Also in attendance were Superintendent Molly Stein, Clerk Jonathan Balls, Principal Debra Daniels, Principal Sue Hansen, High School Counselor Chris Ledbetter and one patron.
 - **1.1 Approval of Agenda**: Chairman Christensen asked if any additional agenda items were needed. With no changes brought forth to the posted agenda, Trustee Erickson made a motion to approve the agenda as posted. The motion was seconded by Trustee Stoor. By a voice vote, the motion passed unanimously.
 - **1.2 Pledge of Allegiance:** Chairman Christensen invited the trustee, administration, and patron to join Clerk Balls in saying the Pledge of Allegiance.

2. Facilities:

2.1 Bond Election PR Plan: Superintendent Stein and Clerk Balls reviewed the remaining steps of the plan with the board to inform the public of the TMS Gym and classroom addition informational meeting on November 1st. Flyers posted around town, emails, and text messages will be used to remind the public of the November 1st meeting and the November 8th election date.

3. Read and Approve Minutes

3.1 Approve the Minutes of September 14th **Board Meeting:** Vice-Chairman Lau had previously given Clerk Balls a few grammatical and sentence structure suggestions to make the minutes read more clearly. Trustee Erickson made a motion to approve the meeting minutes of the September 14th 2016 board meeting as amended. The motion was seconded by Vice-Chairman Lau. By a voice vote, the motion passed unanimously.

4. Ratify Bills / Budget Report

- **4.1 Ratify Bills: September 2016** The board reviewed the bills paid during September 2016 and asked questions of Clerk Balls. After the discussion, Vice-Chairman Lau made a motion to ratify the bills paid during September 2016. The motion was seconded by Trustee Stoor. By a voice vote, the motion passed unanimously.

- **6.** Faculty/Staff Input: Mrs. Hansen mentioned to the board that the following Thursday is the PTO fall festival. All schools will conduct parent teacher conferences on Thursday and Friday of next week.

7. Old Business:

7.1 2015-2016 Financial Audit: With little discussion, Trustee Stoor made a motion to approve the 2015-2016 Financial Audit as 2nd reading. The motion was seconded by Trustee Erickson. By a voice vote, the motion passed unanimously.

8. New Business:

- **8.1 2015-2016 Test Scores:** High School Counselor and testing coordinator Chris Ledbetter shared the test scores for the students during the 2015-2016 school year. She shared the IRI scores for grades Kindergarten through 3rd Grade, the ISAT results for grades 3 11, and the SAT and ACT averages for the High School Students.
- **8.2 2015-2016 Child Nutrition Fund:** Clerk Balls and Superintendent Stein reviewed the Child Nutrition Fund from last year which ended with a \$40,000 negative balance. They reviewed the reasons and causes for this deficit and what was being done to move the program towards a positive fund balance.

9.1 ISBA Annual Convention: The board will attend the ISBA annual convention in Boise on November 9th – 11th. They will receive instruction on board leadership and coordinate the lobbying efforts of the organization for the next legislative session.

Superintendent Stein reviewed with the board the College Application Week at the High school t coming up the following week. She continued with the results of the 'Great Shake Up' a nationwide earthquake drill. To conclude she reviewed the IASA legislative priorities.
